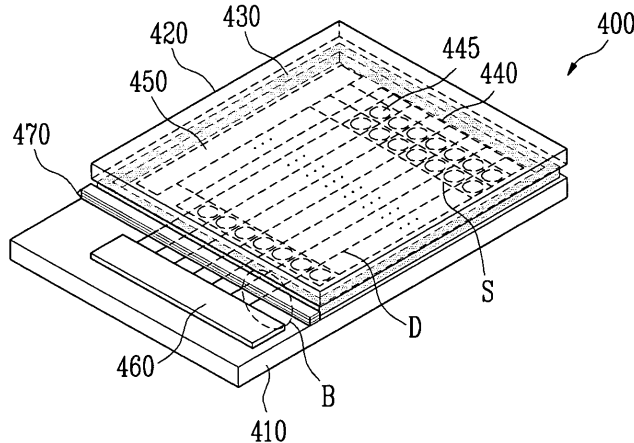

(54) Organic light emitting display device and method for fabricating the same

(57) An organic light emitting display device (400) capable of preventing damage to signal and power lines that drive a pixel region, and a method for fabricating the same. The organic light emitting display device includes a device substrate (410) including at least a pixel region (440); an encapsulation substrate (420) to overlap at least one region of the device substrate including the pixel region; a sealing agent (430) arranged between the

device substrate and the encapsulation substrate to seal a region therebetween; at least one wire formed on the device substrate to extend from inside a sealing region to the outside of the sealing region; a first protective layer formed on the wire; and a second protective layer (470) formed on the first protective layer to overlap at least one edge of the encapsulation substrate which is arranged to cross the wire.

摘要(译)

一种能够防止对驱动像素区域的信号和电源线造成损坏的有机发光显示装置及其制造方法。有机发光显示装置包括器件基板(410)，其包括至少像素区域(440)；封装基板(420)，用于与包括像素区域的器件基板的至少一个区域重叠；密封剂(430)设置在器件基板和封装基板之间，以密封其间的区域；至少一根导线形成在器件基板上，以从密封区域内部延伸到密封区域的外部；在导线上形成第一保护层；第二保护层(470)形成在第一保护层上，以与封装基板的至少一个边缘重叠，该边缘设置成与导线交叉。
