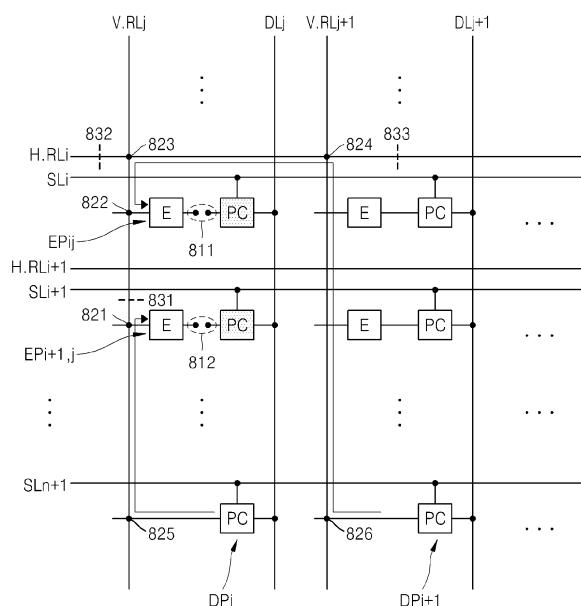

(54) **Organic light emitting display apparatus and method of repairing the same**

(57) An organic light emitting display apparatus (100) includes: a plurality of emission pixels (EP_{ij}, EP_{i+1,j}) arranged in a matrix of a plurality of rows and a plurality of columns, wherein the emission pixels (EP_{ij}, EP_{i+1,j}) each comprise a light emitting diode (LED) (E); a plurality of dummy pixels (DP_j, DP_{j+1}); a plurality of repair lines

(V.RL_i, V.RL_{i+1}), wherein at least one (EP_{ij}) of the plurality of emission pixels is coupled to at least one (DP_j) of the plurality of dummy pixels through one (V.RL_j) of the repair lines; and at least one auxiliary repair line (H.RL_i) coupling at least two (V.RL_j, V.RL_{j+1}) of the plurality of repair lines.
