Description

FIELD

5 **[0001]** The present case relates to an information processing device, an information processing method and an information processing program.

BACKGROUND

10 **[0002]** A technique for detecting a drink intake has been desired. For example, disclosed is a technique for determining a drink intake by detecting a motion of an arm during the drink intake (see Patent Document 1, for example).

[0003] Patent Document 1: Japanese Patent Application Publication No. 2014-79506

20 **[0004]** JP2000245713 (A) discloses a wristwatch type sensor part provided with a skin temperature sensor and a pulse sensor and a belt installing type sensor provided with an acceleration sensor that are connected to a personal computer connected with a display. A behaviour classification such as sleep, eating and drinking, stress, physical exercises and a rest is judged by a behaviour classification judging part on the basis of an analytical result in a skin temperature analysing part, a pulse analysing part and an acceleration analysing part for inputting output signal of the respective sensors. Judged behaviour pattern information is displayed on a display, and sleeping time and physical exercise time are evaluated by an improving behaviour detecting part referring to a pre-set rule.

25 **[0005]** US2008300641 (A1) discloses a cardiac sensor adapted to generate cardiac information descriptive of cardiac functioning of a patient, an activity sensor adapted to generate activity information indicating physical activity of the patient, a processing element adapted to detect a cardiac anomaly based on the cardiac information, an information association element adapted to generate associated cardiac/activity information during the cardiac anomaly, and a data storage apparatus adapted to store the associated cardiac/activity information. A method embodiment includes gener-
30 ating cardiac information descriptive of cardiac functioning of a patient, detecting a cardiac anomaly based on the cardiac information, generating activity information descriptive of physical activity of the patient during the cardiac anomaly, associating the cardiac information and the activity information, during the cardiac anomaly, to generate associated cardiac/activity information, and storing the associated cardiac/activity information.

35 DISCLOSURE OF THE INVENTION

PROBLEMS TO BE SOLVED BY THE INVENTION

40 **[0006]** However, there are various motions of an arm during a drink intake. It is therefore difficult to accurately detect an action of the drink intake. For example, the motion of the arm assumed in the above-mentioned invention is only a part of motions during the drink intake. The drink intake may not be necessarily detected during other motions during the drink intake. There are various motions of an arm in a daily life. Therefore, a false detection may occur.

45 **[0007]** According to an aspect of the present case, provided is an information processing device, an information processing method, and an information processing program capable of detecting a drink intake under various conditions, independently of a specific action.

EFFECTS OF THE INVENTION

55 **[0009]** It is possible to detect a drink intake under various conditions, independently of a specific action.

DESCRIPTION OF EMBODIMENTS

[0011] Hereinafter, a description will be given of embodiments with reference to drawings.

(First Embodiment)

[0012] FIG. 1 is a block diagram of a hardware configuration of an information processing device 100 in accordance with a first embodiment. As illustrated in FIG. 1, the information processing device 100 includes a CPU 101, a RAM 102, a storage device 103, a display device 104, a heartbeat measuring device 105 and the like. These devices are interconnected through a bus or the like.

[0013] The CPU (Central Processing Unit) 101 is a Central Processing Unit. The CPU 101 includes one or more cores. The RAM (Random Access Memory) 102 is a volatile memory that temporarily stores programs executed by the CPU 101 and data processed by the CPU 101.

[0014] The storage device 103 is a nonvolatile storage device. For example, a ROM (Read Only Memory), a solid state drive (SSD) such as a flash memory, or a hard disk driven by a hard disk drive can be used as the storage device 103. The information processing program of the present embodiment is stored in the storage device 103. The display device 104 is a liquid crystal display, an electroluminescence panel, or the like, and displays the result of a drink intake detection process described later.

[0015] The heartbeat measuring device 105 is a device that measures the heartbeat (pulse) of an object such as a person or an animal taking a drink. The heartbeat measuring device 105 is not particularly limited as long as it can

measure heartbeat (pulse). For example, the heartbeat measuring device 105 may be an electrocardiograph or a pulsation sensor. The drink is not particularly limited as long as it is a liquid drink. However, when an alcohol is taken, there may be a case where a heart rate may increase because of absorption or degradation of the alcohol after taking the alcohol. It is therefore preferable that a non-alcohol drink is used as the drink in the embodiment.

[0016] The information processing program stored in the storage device 103 is deployed in the RAM 102 in an executable manner. The CPU 101 executes the information processing program deployed in the RAM 102. This causes the information processing device 100 to execute each process. FIG. 2A is a block diagram of functions implemented by the execution of the information processing program. The execution of the information processing program implements a heart rate acquisition unit 10, a heartbeat fluctuation calculation unit 20, a determination unit 30, a storage 40 and so on. In the following, the storage means a database.

[0017] FIG. 2B is a functional block diagram of functions of the heartbeat fluctuation calculation unit 20. As illustrated in FIG. 2B, the heartbeat fluctuation calculation unit 20 functions as a speed feature calculation unit 21, a difference feature calculation unit 22, an intersection feature calculation unit 23, a baseline feature calculation unit 24, a fluctuation feature calculation unit 25, an amplitude feature calculation unit 26, an area feature calculation unit 27 and so on.

(Drink intake detection process)

[0018] FIG. 3 illustrates an example of a flowchart of a drink intake detection process. As illustrated in FIG. 3, the heart rate acquisition unit 10 acquires heart rate fluctuation with respect to time by acquiring heartbeat from the heartbeat measuring device 105 (Step S1). FIG. 4 illustrates heart rate fluctuation with respect to time caused by a drink intake. In FIG. 4, a horizontal axis indicates an elapsed time, and a vertical axis indicates a heart rate. The heart rate is the number of beats per unit time, more specifically, the number of beats per minute. Hereinafter, unless otherwise specified, the heart rate means the number of beats per minute. The drink intake means that a drink is swallowed down one's throat once or more within a predetermined time range. When a new drink is swallowed after the predetermined time range, a second drink intake is performed. FIG. 4 illustrates heart rate fluctuation caused by a single drink intake.

[0019] As illustrated in FIG. 4, the heart rate fluctuation with respect to time caused by the drink intake has a tendency in which the heart rate rapidly increases at a start time of the drink intake and slowly decreases after an end of the drink intake.

The fluctuation has a tendency in which the heart rate increases at a constant speed at the start time of the drink intake and decreases at a variable speed after the end of the drink intake. The fluctuation has a tendency in which the heart rate decreases just after rapid increasing of the heart rate at the start time of the drink intake. The fluctuation has a tendency in which a baseline (average value) of the heart rate after the drink intake is larger than a baseline of the heart rate before the drink intake. The fluctuation has a tendency in which a variation (dispersion) of the heart rate after the drink intake is larger than the variation of the heart rate before the drink intake. And so, it is possible to determine whether an object takes a drink or not, by storing these tendencies in a database in advance and comparing measured heart rate fluctuation of the object with these tendencies. The database includes a text file and a binary file.

[0020] As illustrated in FIG. 3, the heartbeat fluctuation calculation unit 20 calculates a feature of the drink intake in the heart rate fluctuation acquired by the heart rate acquisition unit 10 (Step S2). FIG. 5 illustrates an example of a flowchart of a calculation process of a feature. The speed feature calculation unit 21 calculates a speed feature of the heart rate fluctuation because the heart rate fluctuation of the drink intake has a tendency in which the heart rate rapidly increases at a start time of the drink intake and slowly decreases after the drink intake (Step S11).

[0021] As a speed feature, the speed feature calculation unit 21 calculates a heart rate increasing speed (speed feature i) from a start time candidate of the drink intake, a heart rate decreasing speed (speed feature ii), and a ratio of the heart rate increasing speed and the heart rate decreasing speed (speed ratio of increasing and decreasing of the heart rate: speed feature iii). FIG. 6 illustrates examples of calculation of the speed feature i to the speed feature iii. FIG. 7A illustrates an example of a flowchart of a calculation process of the speed feature i to the speed feature iii.

[0022] As illustrated in FIG. 7A, the speed feature calculation unit 21 calculates a start time candidate of the drink intake (Step S21). For example, the start time candidate of the drink intake is a start time of increasing during an increasing period of the heart rate for a predetermined time (for example, 5 seconds) or more. The start time candidate of the drink intake may be a time point at which a rising of the heart rate is detected. Next, the speed feature calculation unit 21 calculates a time of a maximum heart rate (Step S22). For example, the maximum heart rate is a maximum value of the heart rate during the increasing period of the heart rate. The increasing period of the heart rate may be considered as a constant multiplication of period from time when an object holds a drink in his mouth to time when the object swallows the drink down his throat (for example, from time when the object holds 20 ml of the drink in his mouth to time when the object swallows the drink at a time (for example, 3 seconds)). For example, the multiplication of the time is a period in which water of 20 ml in 1 liter is continuously swallowed 50 times (for example, 150 seconds).

[0023] Next, the speed feature calculation unit 21 calculates the heart rate increasing speed by a function approximation (Step S23). For example, the speed feature calculation unit 21 calculates the heart rates from the start time candidate

of the drink intake to the time of the maximum heart rate and calculates an inclination a_u of an approximated line obtained by a function approximation of the calculated heart rates.

[0024] Next, the speed feature calculation unit 21 calculates time of a minimum heart rate (Step S24). For example, the minimum heart rate is a minimum value of heart rates in a heart rate decreasing period. The heart rate decreasing period may be considered as a period from time when a drink is swallowed to time when the liquid reaches a stomach (a period until the swallowed drink reaches the stomach (for example, 10 seconds)). Next, the speed feature calculation unit 21 calculates the heart rate decreasing speed by a function approximation (Step S24). For example, the speed feature calculation unit 21 calculates the heart rates from the time of the maximum heart rate to the time of the minimum heart rate and calculates an inclination a_d of an approximated line obtained by a function approximation of the calculated heart rates, as the heart rate decreasing speed.

[0025] Next, the speed feature calculation unit 21 calculates a ratio of the heart rate increasing speed and the heart rate decreasing speed ($|a_u|/|a_d|$) as the speed ratio of increasing and decreasing of the heart rate (Step S26). A value indicating a difference between the increasing and the decreasing may be used instead of the speed ratio.

And so, the speed feature calculation unit 21 may calculate a difference between the increasing speed and the decreasing speed ($|a_u| - |a_d|$) as the speed feature iii. The speed feature calculation unit 21 calculates at least one of the speed feature i to the speed feature iii.

[0026] Next, the heart rate fluctuation of the drink intake with respect to time has the tendency in which the heart rate increases at a constant speed at the start time of the drink intake and decreases at a variable speed after the end of the drink intake. Therefore, as illustrated in FIG. 5, the difference feature calculation unit 22 calculates the difference feature of the heart rate fluctuation (Step S12). In concrete, as the difference feature, the difference feature calculation unit 22 calculates a difference between a measured value and the approximated line within the increasing period (difference within the increasing period: difference feature iv), a difference between a measured value and the approximated line of the decreasing period (difference within the decreasing period: difference feature v), and a ratio of the difference of the increasing period and the difference of the decreasing period (ratio of the difference between the increasing period and the decreasing period: difference feature vi). The difference may be called an error between the measured value and the approximated line. FIG. 7B illustrates an example of a flowchart of a calculation process of the difference feature iv to the difference feature vi. FIG. 8 illustrates a calculation of the difference feature iv to the difference feature vi.

[0027] As illustrated in FIG. 7B, the difference feature calculation unit 22 determines the heart rate increasing period (Step S31). For example, the increasing period is a period from the start time candidate of the drink intake to the time of the maximum heart rate. Next, the difference feature calculation unit 22 calculates the difference within the increasing period from the difference between the measured value and the approximated line (Step S32). For example, the difference within the increasing period is a value corresponding to a coefficient of determination R_u of the measured value and the approximated line of the increasing period. The coefficient of determination R_u may be expressed by the following formula (1).

[Formula 1]

$$R_u = \left(\sum_{i=1}^{M_u} (\hat{y}_i - \bar{y})^2 \right) / \left(\sum_{i=1}^{M_u} (y_i - \bar{y})^2 \right) \quad (1)$$

y_i : measured value, $\bar{y}$: average, $\hat{y}_i$: predicted value
 M_u : number of measured data

[0028] Next, the difference feature calculation unit 22 determines the decreasing period (Step S33). For example, the decreasing period is a period from the time of the maximum heart rate to the time of the minimum heart rate. Next, the difference feature calculation unit 22 calculates the difference of the decreasing period from the difference between the measured value and the approximated line (Step S34). For example, the difference of the decreasing period is a value corresponding to a coefficient of determination R_d of the measured value and the approximated line of the decreasing period. R_d may be expressed by the following formula (2).

[Formula 2]

$$R_d = \left(\sum_{i=1}^{M_d} (\hat{y}_i - \bar{y})^2 \right) / \left(\sum_{i=1}^{M_d} (y_i - \bar{y})^2 \right) \quad (2)$$

y_i : measured value, $\bar{y}$: average, $\hat{y}_i$: predicted value
 M_d : number measured data

[0029] Next, as the difference ratio between the increasing period and the decreasing period, the difference feature calculation unit 22 calculates a value corresponding to the ratio R_u/R_d of the difference of the increasing period and the difference of the decreasing period (Step S35). A value indicating a difference between the increasing and the decreasing may be used instead of the difference ratio. And so, the difference feature calculation unit 22 may calculate a difference between the difference of the increasing period and difference of the decreasing period ($|R_u| - |R_d|$) as the difference feature vi. The difference feature calculation unit 22 calculates at least one of the difference feature iv to the difference feature vi.

[0030] Next, the heart rate fluctuation of the drink intake has a tendency in which the heart rate decreases just after rapid increasing of the heart rate at the start time of the drink intake. Therefore, as illustrated in FIG. 5, the intersection feature calculation unit 23 calculates an intersection feature of the heart rate fluctuation (Step S13). In concrete, as the intersection feature, the intersection feature calculation unit 23 calculates an intersection angle of feature (intersection feature vii) indicating decreasing just after the time of the maximum heart rate. FIG. 9 illustrates a calculation of the intersection feature vii. FIG. 7C illustrates an example of a flowchart of a calculation process of the intersection feature vii. As illustrated in FIG. 7C, the intersection feature calculation unit 23 calculates the intersection angle θ as an intersection angle between the approximated line of the increasing period and the approximated line of the decreasing period (Step S41). The intersection angle θ may be calculated by the following formula (3) and the following formula (4).

[0031] Next, the heart rate fluctuation of the drink intake has the tendency in which a baseline of the heart rate after the drink intake is larger than a baseline of the heart rate before the drink intake. Therefore, as illustrated in FIG. 5, the baseline feature calculation unit 24 calculates a baseline feature of the heart rate fluctuation (Step S14). In concrete, as the baseline feature, the baseline feature calculation unit 24 calculates a baseline before the increasing period (baseline feature viii), a baseline feature after the decreasing period (baseline feature ix) and a ratio of the baseline before the increasing period and the baseline after the decreasing period (a baseline ratio between before the increasing and after the decreasing: baseline feature).

[0032] FIG. 10 illustrates a calculation of the baseline feature viii to the baseline feature ix. FIG. 11A illustrates an example of a flowchart of a calculation process of the baseline feature viii to the baseline feature ix. As illustrated in FIG. 11A, the baseline feature calculation unit 24 determines the period before the increasing (Step S51). For example, the period before the increasing is a period from a predetermined time before the start time candidate of the drink intake to the start time candidate of the drink intake. The predetermined time may be two minute or 30 minutes, for example. The predetermined time before the start time candidate of the drink intake is time just after a variation per a unit section before the start time of the drink intake exceeds a predetermined value (for example, 0.1 or 1).

[0033] Next, the baseline feature calculation unit 24 calculates the baseline of the period before the increasing, as a value corresponding to an average μ_u of the heart rate of the period before the increasing (Step S52). Next, the baseline feature calculation unit 24 determines the period after the decreasing (Step S53). For example, the period after the decreasing is a period from the time of the minimum heart rate to a predetermined time after the time of the minimum heart rate. The predetermined time may be two minutes or 30 minutes, for example. The predetermined time after the time of the minimum heart rate is time just before a variation per a unit section after the time of the minimum heart rate exceeds a predetermined value (for example, 0.1 or 1). Next, the baseline feature calculation unit 24 calculates the baseline of the period after the decreasing, as a value corresponding to an average μ_d of the heart rate of the period after the decreasing (Step S54).

[0034] Next, as the baseline ratio between the period before the increasing and the period after the decreasing, the baseline feature calculation unit 24 calculates a ratio μ_d/μ_u between the baseline of the period before the increasing and the baseline of the period after the decreasing (Step S55). A value indicating a difference between before the increasing and after the decreasing may be used instead of the baseline ratio. And so, the baseline feature calculation

unit 24 may calculate a difference between the baseline of the period before the increasing and the baseline of the period after the decreasing ($|\mu_u| - |\mu_d|$) as the baseline feature ix. The baseline feature calculation unit 24 calculates at least one of the baseline feature viii to the baseline feature ix.

[0035] Next, the heart rate fluctuation has the tendency in which a variation (dispersion) of the heart rate after the drink intake is larger than the variation of the heart rate before the drink intake. Therefore, as illustrated in FIG. 5, the fluctuation feature calculation unit 25 calculates a fluctuation feature of the heart rate fluctuation (Step S15). In concrete, as the fluctuation feature, the fluctuation feature calculation unit 25 calculates a fluctuation of the period before the increasing (fluctuation feature xi), a fluctuation of the period after the decreasing (fluctuation feature xii) and a ratio between the fluctuation of the period before the increasing and the fluctuation of the period after the decreasing (fluctuation ratio between the period before the increasing and the period after the decreasing: fluctuation feature xiii). FIG. 11B illustrates an example of a flowchart of a calculation process of the fluctuation feature. FIG. 12 illustrates a calculation of the fluctuation feature.

[0036] As illustrated in FIG. 11B, the fluctuation feature calculation unit 25 calculates the fluctuation of the period before the increasing as the dispersion of the heart rate before the increasing (Step S61). For example, the fluctuation of the period before the increasing is a value corresponding to a dispersion V_u from the average μ_u of the heart rate of the period before the increasing. The dispersion V_u may be expressed by the following formula (5).

[Formula 5]

$$V_u = \sum_{i=1}^{Q_u} (y_i - \mu_u)^2 / Q_u \quad (5)$$

[0037] Next, the fluctuation feature calculation unit 25 calculates the fluctuation of the period after the decreasing as a dispersion of the heart rate of the period after the decreasing (Step S62). For example, the fluctuation of the period after the decreasing is a value corresponding to a dispersion V_d from the average μ_d of the heart rate of the period after the decreasing. The dispersion V_d may be expressed by the following formula (6).

[Formula (6)]

$$V_d = \sum_{i=1}^{Q_d} (y_i - \mu_d)^2 / Q_d \quad (6)$$

[0038] Next, the fluctuation feature calculation unit 25 calculates a ratio V_u/V_d between the period before the increasing and the period after the decreasing as the fluctuation ratio between the period before the increasing and the period after the decreasing (Step S63). A value indicating a difference between before the increasing and after the decreasing may be used instead of the ratio. And so, the fluctuation feature calculation unit 25 may calculate a difference ($|V_u| - |V_d|$) between the fluctuation of the period before the increasing and the fluctuation of the period after the decreasing, as the fluctuation feature xiii. The fluctuation feature calculation unit 25 calculates at least one of the fluctuation feature xi to the fluctuation feature xiii.

[0039] Next, in the heart rate fluctuation caused by the drink intake, an increasing width of the heart rate may be used as a feature. And so, as illustrated in FIG. 5, the amplitude feature calculation unit 26 calculates an amplitude feature (Step S16). In concrete, as illustrated in FIG. 13, as an amplitude feature xiv, the amplitude feature calculation unit 26 calculates an increasing width of the maximum heart rate of the increasing period. FIG. 11C illustrates an example of a flowchart of a calculation process of the amplitude feature xiv. As illustrated in FIG. 11C, the amplitude feature calculation unit 26 calculates a heart rate at the time of the maximum heart rate (Step S71). For example, when the heart rate = zero is a standard, a value of the maximum heart rate may be used as the amplitude feature xiv. Alternatively, when a heart rate at the start time candidate of the drink intake is a standard, a difference between the maximum heart rate and the heart rate at the start time candidate of the drink intake may be used as the amplitude feature xiv.

[0040] Next, in the heart rate fluctuation caused by the drink intake, an area of the heart rate (integral value) may be used as a feature. And so, as illustrated in FIG. 5, an area feature calculation unit 27 calculates an area feature (Step S17). In concrete, as illustrated in FIG. 14, as an area feature xv, a total (integral value) of the heart rate increasing width of the increasing period of the heart rate and the decreasing period of the heart or a time-averaged heart rate increasing width. The heart rate increasing width may be an increasing width from the average μ_u of the heart rate of the period before the increasing. FIG. 11D illustrates an example of a flowchart of a calculation process of the area feature xv. As illustrated in FIG. 11D, the area feature calculation unit 27 calculates the area feature xv by calculating a total value of increasing widths from the baseline of the period before the increasing from the start time candidate of the drink intake to the time of the minimum heart rate (Step S81).

[0041] A collinear approximation is used for the calculation of the speed feature i to the speed feature iii and the difference feature iv to the difference feature vi. However, a curve approximation such as a quadratic curve may be used. However, it is preferable that the collinear approximation is used in the increasing period because the heart rate

of the increasing period tends to rapidly increase. It is preferable that the curve approximation is used in the decreasing period because the heart rate of the decreasing period tends to slowly decrease. And so, as illustrated in FIG. 15, the collinear approximation may be used in the increasing period, and the curve approximation is used in the decreasing period.

[0042] The storage 40 stores a model that is made in advance. The model includes a model of the drink intake and a model of a drink non-intake. The model of the drink intake includes the speed features i to iii, the difference features iv to vi, the intersection feature vii, the baseline features viii to x, the fluctuation feature xi to xiii, the amplitude feature xiv and the area feature xv, in the heart rate fluctuation caused by the drink intake. The model of the drink non-intake includes the speed features i to iii, the difference features iv to vi, the intersection feature vii, the baseline features viii to x, the fluctuation feature xi to xiii, the amplitude feature xiv and the area feature xv, in the heart rate fluctuation during a period in which a drink is not taken. These models may be made with use of measured values of a specific object using the drink intake detection process or with use of measured values of many and unspecified users. When a plurality of measured values are used, an average of the measured values may be used. Alternatively, an analyzer may optionally make the model of the drink intake and the mode of the drink non-intake.

[0043] FIG. 16 illustrates an example of a flowchart for making a model stored in the storage 40. In the example, a model is made in advance with use of a measured value of a heart rate of an object using the drink intake detection process. As illustrated in FIG. 16, the heart rate acquisition unit 10 reads, in order, heart rate data to which a label is added (Step S91). For example, the label may be made by pushing a button at timing when the object takes a drink.

[0044] Next, the heartbeat fluctuation calculation unit 20 calculates a feature associated with increasing and decreasing of the heart rate fluctuation with respect to time (Step S92). The feature includes the speed features i to iii, the difference features iv to vi, the intersection feature iii, the baseline features viii to x, the fluctuation features xi to xiii, the amplitude feature xiv and the area feature xv. Next, the heartbeat fluctuation calculation unit 20 stores the calculated feature in the storage 40 as a database for model making, together with the label (Step S93). Next, the determination unit 30 determines whether the process is finished with respect to all data (Step S94). When it is determined as "No" in Step S94, Step S91 is executed again. When it is determined as "Yes" in Step S94, the determination unit 30 makes a model of the drink intake and a model of the drink non-intake, with use of the database for model making (Step S95). These models are stored in the storage 40 as a model used for the drink intake detection process.

[0045] Next, as illustrated in FIG. 3, the determination unit 30 determines whether the fluctuation of the heart rate during the drink intake detection process is caused by a drink intake, with use of the feature calculated by the heartbeat fluctuation calculation unit 20 (Step S3). FIG. 17 illustrates an example of a flowchart of a determination process in this case. As illustrated in FIG. 17, the determination unit 30 calculates a coincidence degree (divergence degree) between the feature calculated from the heart rate fluctuation measured during the drink intake detection process and the model of the drink intake stored in the storage 40 and between the feature and the model of the drink non-intake stored in the storage 40 (Step S101). The coincidence degree indicates a similarity degree between the feature calculated from the heart rate fluctuation measured during the drink intake detection process and the model of the drink intake or a similarity degree between the feature and the model of the drink non-intake. Therefore, the coincidence means a similarity degree or an analogous degree. In the following, a Mahalanobis distance is described as a coincidence calculation. However, any algorithm such as a support vector machine, a boosting or a neural network may be applied to the coincidence calculation.

[0046] For example, the determination unit 30 uses the Mahalanobis distance for calculating the coincidence degree (divergence degree). The determination unit 30 uses an average vector and a covariance matrix as parameters when calculating the Mahalanobis distance. The average vector and the covariance matrix of the drink intake are μ_d and Σ_d . The average vector and the covariance matrix of the drink non-intake are μ_n and Σ_n . Data to be determined is $x=(x_1, x_2, \dots)^T$. $x_1, x_2, \dots$ indicate the feature i, the feature ii, $\dots$. The Mahalanobis distance may be expressed by the following formula (7) and the following formula (8). When the covariance matrix is a diagonal matrix, a normalized Euclid distance (that is normalized so that dispersions of features are equal to each other) may be used. The covariance matrix is a unit matrix, an Euclid distance may be used.

[0047] Next, the determination unit 30 determines that the heart rate fluctuation measured during the drink intake detection process belongs to one of which the distance is smaller (Step S102). Therefore, when D_d is larger than D_n as illustrated in FIG. 18, the determination unit 30 determines that the heart rate fluctuation measured during the drink intake detection process is the heart rate fluctuation of the drink non-intake. In FIG. 18, a distance using only the features i and ii is illustrated for simplification. Information associated with a viscosity of a liquid may be estimated with use of D_d and D_n , and the estimated information may be added to the determination result of the determination unit 30. For example, when D_d is smaller than D_n and a ratio of D_d and D_n is equal to a predetermined value (for example, 2) or less, the determination unit 30 determines that the heart rate fluctuation measured during the drink intake detection process is the heart rate fluctuation of the intake of a drink having a low viscosity. Alternatively, a distance from not the model of the drink non-intake but a plurality of models of the drink intake may be calculated, a component of the drink may be estimated, and the calculated distance and the estimated component may be added to the determination result of the determination unit 30. For example, a distance from a model of pure water intake, a model of intake of a drink including salt, and a model of intake of a drink including sugar may be used, an including amount of the salt and the sugar may be estimated, and it may be determined that the heart rate fluctuation is that of the intake of the drink including 10 mg of salt and 10 mg of sugar.

[0048] In accordance with the embodiment, it is determined whether a heart rate fluctuation of an object with respect to time is caused by a drink intake, on a basis of a coincidence degree between a feature extracted from the heart rate fluctuation of the object and a feature of a drink intake stored in a database. It is therefore possible to detect a drink intake with high accuracy. It is possible to detect a drink intake by only acquiring heart rate fluctuation. The heart rate fluctuation is measured. Therefore, it is not necessary for the object to perform a specific action before and after a drink intake. When a wearable device put on an arm for measuring a heart rate is used, it is possible to easily detect a drink intake with low load.

[0049] When a coincidence degree with the feature of the drink intake stored in the database is higher than a coincidence degree with the feature of the drink non-intake stored in the database, it is determined that the heart rate fluctuation is caused by a drink intake. Therefore, the detection accuracy of the drink intake is improved. It may not be necessarily calculated the coincidence degree with the feature of the drink non-intake. For example, when the coincidence degree with the feature of the drink intake stored in the database is equal to or more than a threshold, it may be determined that the heart rate fluctuation is caused by a drink intake. For example, in Step S102 of FIG. 17, the coincidence degree is compared with a threshold. At least one of the above-mentioned features is used. When the features i to iii, the difference features iv to vi and the intersection feature vii are used, the detection accuracy of a drink intake becomes specifically high.

[0050] It is possible to advice life style habit with the determination result of the determination unit 30, by adding an action such as exercise and sleep. For example, when no drink is taken for a predetermined period after getting up, it is displayed "please take a drink after getting up". Alternatively, when no drink is taken at a predetermined time, it is displayed "You may forget taking a medicine".

[0051] The determination result may include at least one of the number of drink intake, the start time of the drink intake, the end time of the drink intake, the viscosity of the liquid, the component of the drink, and the amount of taken drink. The number of drink intake corresponds to the number of the determination as drink intake for a day. The start time of the drink intake, for example, corresponds to the start time candidate of the drink intake. The end tie of the drink intake, for example, corresponds to the time of the maximum heart rate. The amount of taken drink, for example, corresponds to a value obtained by dividing the period of the drink intake (difference between the end time of the drink intake and the start time of the drink intake) and a period for performing a single swallowing of the drink. The period for performing a single swallowing is stored in the database in advance, and may be made with respect to age groups, sex groups, or individuals.

[0052] FIG. 19 illustrates an example of a flowchart of a calculation of the amount of taken drink. The heart rate acquisition unit 10 acquires the heart rate fluctuation by acquiring the heartbeat from the heartbeat measuring device 105 (Step S1a). Next, the heartbeat fluctuation calculation unit 20 calculates a feature of the drink intake in the heart rate fluctuation acquired by the heart rate acquisition unit 10 (Step S2a). Next, the determination unit 30 determines whether the heart rate fluctuation during the drink intake detection process is caused by the drink intake, with use of the feature calculated by the heartbeat fluctuation calculation unit 20 (Step S3a). Next, when it is determined as the drink intake (Yes in Step S4a), the determination unit 30 calculated the amount of taken drink (Step S5a). After Step S5a or it is not determined as the drink intake in Step S3a (No in Step S4a), the determination unit 30 determines whether the measuring is finished (Step S6a). When it is determined as "No" in Step S6a, Step S1a is executed again. When it is determined as "Yes" in Step S6a, the flowchart is terminated.

(Second Embodiment)

[0053] A second embodiment is an example in which action information of an object has an influence on the drink

intake detection process. FIG. 20 illustrates a block diagram of a hardware structure of an information processing device 100a in accordance with the second embodiment. As illustrated in FIG. 20, the information processing device 100a further has an action information detection device 106. The action information detection device 106 is a device for detecting action information of the object.

[0054] The action information detection device 106 detects an action having a low correlation with the drink intake. For example, the action information detection device 106 detects an action in which no drink is physically taken. In concrete, the action information detection device 106 detects such as sleep, phonation, chewing, or sigh. The action information detection device 106 detects an action in which the drink is not taken with high possibility. In concrete, the action information detection device 106 detects a general habit. For example, the action information detection device 106 detects an action in which the object is grounded and moves his legs, such as walking, running or stairs stepping. The action information detection device 106 detects an action in which the object moves his hand, such as dishwashing or cleaning. The action information detection device 106 detects an action for riding on a specific vehicle such as a motorcycle. The action information detection device 106 detects an action of excretion. The action information detection device 106 detects an action of bathing. The action information detection device 106 detects a habit of an individual. For example, the action information detection device 106 detects such as talking with a specific person, meeting, a case where the object doesn't desire to urinate (action of lining up).

[0055] Alternatively, the action information detection device 106 detects an action having a high correlation with the drink intake. For example, the action information detection device 106 detects an action unique to the drink intake (motion of a body part such as an arm or breast of which an inclination changes according to the drink intake). In concrete, the action information detection device 106 detects such as preliminary motion of putting liquid in a container, a rotation of hand of opening a cap of a PET bottle, a motion of front and behind or up and down for moving a container to a mouth, a stationary condition for a period of holding a container in his mouth and swallowing, a motion of behind and down of swallowing liquid in a container, or a motion front and behind or up and down of putting a container on a desk or the like. The action information detection device 106 detects an action in which the object takes a drink with high possibility. For example, the action information detection device 106 detects a general habit. For example, the action information detection device 106 detects such as an action of taking a drink after getting up and before sleeping, an action of taking a drink before or after bathing, or an action of taking a drink before or after exercise. The action information detection device 106 detects a habit of an individual. For example, the action information detection device 106 detects an action of taking water at a specific time (for example, 15:00), or an action of taking water in a specific place (for example, kitchen). The action information detection device 106 may determine the action with use of a motion data or determine time and place with use of data associated with time or place, with use of a conventional technology or with use of a label that the object makes by pushing a button during each motion.

[0056] FIG. 21 illustrates an example of a flowchart of the drink intake detection process of the embodiment. As illustrated in FIG. 21, the heart rate acquisition unit 10 acquires a heartbeat from the heartbeat measuring device 105 and acquires the heart rate fluctuation with respect to time (Step S111). The heart rate acquisition unit 10 acquires action information of the object together with the heart rate fluctuation with respect to time when the action information detection device 106 detects an action of the object. Next, the heartbeat fluctuation calculation unit 20 calculates a feature of the drink intake in the heart rate fluctuation acquired by the heart rate acquisition unit 10 (Step S112).

[0057] Next, the determination unit 30 calculates a Mahalanobis distance between the feature calculated by the heartbeat fluctuation calculation unit 20 and the model of the drink intake and between the feature and the model of the drink non-intake (Step S113). Next, the determination unit 30 calculates a ratio of the distances (Step S114). The ratio may be a distance from the model of the drink intake / a distance from the model of the drink non-intake.

[0058] Next, when the heart rate fluctuation acquired by the heart rate acquisition unit 10 includes a motion data of the object, the determination unit 30 determines an action associated with the motion data (Step S115). Next, when the heart rate fluctuation acquired by the heart rate acquisition unit 10 includes a data associated with time or a place of the object, the determination unit 30 determines the time and the place (Step S116).

[0059] Next, the determination unit 30 refers to thresholds stored in the storage 40 in advance, and acquires a threshold associated with an action detected by the action information detection device 106. When the distance ratio calculated in Step S114 is equal to or less than a threshold, the determination unit 30 determines that a drink is not taken (Step S117). Next, the determination unit 30 determines whether the measuring is finished (Step S118). When it is determined as "No" in Step S118, Step S111 is executed again. When it is determined as "Yes" in Step S118, the flowchart is terminated.

[0060] In accordance with the embodiment, the detection accuracy of the drink intake is improved because the action information of the object has an influence on the determination whether the heart rate fluctuation of the object is caused by the drink intake or not. For example, when the threshold of the distance ratio calculated in Step S114 in a case where the possibility of the drink intake is low, it is possible to suppress a false detection of the drink intake. When the threshold of the distance ratio calculated in Step S114 in a case where the possibility of the drink intake is high, it is possible to suppress a false detection of the drink intake.

(Third Embodiment)

[0061] FIG. 22A illustrates a functional block diagram of an information processing device 100b in accordance with a third embodiment. The function is implemented by execution of the information processing program. As compared with the first embodiment, a body function quantification unit 50 is further implemented. FIG. 22B illustrates a functional block diagram of each function of the heartbeat fluctuation calculation unit 20. Each function of the heartbeat fluctuation calculation unit 20 is the same as the first embodiment. The body function quantification unit 50 quantifies the body function by comparing the feature obtained from the heart rate fluctuation acquired in the drink intake detection process with the model of the drink intake. For example, the body function quantification unit 50 determines that the object is thirst twice as usual when an acquired increasing speed of the heart rate is twice as the increasing speed of the model. The body function quantification unit 50 determines that function of the body of the object becomes weak when an acquired decreasing speed of the heart rate is half of the decreasing speed of the model.

[0062] FIG. 23 illustrates an example of a flowchart of a drink intake detection process in accordance with the embodiment. As illustrated in FIG. 23, the heart rate acquisition unit 10 acquires the heart rate fluctuation by acquiring a heartbeat from the heartbeat measuring device 105 (Step S121). Next, the heartbeat fluctuation calculation unit 20 calculates a feature of the drink intake in the heart rate fluctuation acquired by the heart rate acquisition unit 10 (Step S122). Next, the determination unit 30 determines the drink intake or the drink non-intake, with use of the feature calculated in Step S122 (Step S123).

[0063] Next, the body function quantification unit 50 determines whether it is determined as "drink intake" in Step S123 (Step S124). When it is determined as "Yes" in Step S124, the body function quantification unit 50 refers to the storage 40 and acquires each feature of the model of the drink intake (Step S125). When the model of the drink intake includes a plurality of features, the body function quantification unit 50 may an average of the features.

[0064] Next, the body function quantification unit 50 calculates a ratio of each feature calculated in Step S122 and each feature acquired in Step S125 (Step S126). Next, the body function quantification unit 50 quantifies the thirsty, in accordance with the increasing speed of the heart rate (Step S127). Next, the body function quantification unit 50 quantifies the motion of the body, in accordance with the decreasing speed of the heart rate (Step S128). The body function quantification unit 50 determines whether the measuring is finished (Step S129). When it is determined as "Yes" in Step S129, the flowchart is terminated. When it is determined as "No" in Step S129, Step S121 is executed again. When it is determined as "No" in Step S124, Step S129 is executed again.

[0065] In accordance with the embodiment, it is possible to quantify the body function of the object by using a relationship between the feature of the heart rate fluctuation of the object and the feature stored in the database.

(Another feature)

[0066] In the above-mentioned embodiments, the speed feature, the difference feature and so on of the heart rate fluctuation are used. However, the feature is not limited. For example, a wave pattern of the heart rate fluctuation may be used as the feature. In concrete, when a coincidence degree (divergence degree) between a wave pattern of the heart rate of the object and a wave pattern of the drink intake that is stored in the storage 40 in advance is high, it may be determined that the case is the drink intake.

[0067] A heart rate fluctuation signal with respect to time stored in the storage 40 is $s(t)$. A heart rate fluctuation signal acquired in the drink intake detection process is $x(t)$. FIG. 24A illustrates $s(t)$. FIG. 24B illustrates $x(t)$. In this case, a coincidence between the patterns may be expressed by the following formula (9). In the following formula (9), a difference is calculated. And, the smaller the value is, the high the coincidence is. N is a total number of the signals. The number of the signals are the number of signals within seconds from the start time of the period before increasing to the end time of the period after the decreasing. When the coincidence is equal to or more than a threshold set in advance, it may be determined that the case is the drink intake. When the number of the signals is different from the total number N of the signals, the signals may be interpolated or thinned out.

(Another device configuration)

[0068] FIG. 25A and FIG. 25B illustrate another device configuration of the information processing device 100. As illustrated in FIG. 25A, the information processing device 100 may have a structure in which a server wirelessly sends data to a wearable device and wirelessly receives data from the wearable device. The server has the CPU 101, the

RAM 102, the storage device 103 and a wireless device 107. The wearable device has the display device 104, the heartbeat measuring device 105, and a wireless device 108. Alternatively, as illustrated in FIG. 25B, the information processing device may have a structure in which data is wirelessly sent or received among a server, a terminal and a wearable device. In this case, the server has the CPU 101, the RAM 102, the display device 103 and the wireless device 107. The terminal has the display device 104 and the wireless device 108. The wearable device has the heartbeat measuring device 105 and a wireless device 109. When the action information detection device 106 is provided, the wearable device may have the action information detection device 106.

[0069] The heart rate acquisition unit 10 acts as an example of a heart rate acquisition unit configured to acquire a heart rate of an object. The heartbeat fluctuation calculation unit 20 acts as an example of a feature extraction unit configured to extract a feature from heart rate fluctuation with respect to time that is acquired by the heart rate acquisition unit. The storage 40 acts as an example of a storage configured to, in advance, store information associated with heart rate fluctuation of a drink intake. The determination unit 30 acts as an example of a determination unit configured to determine whether the heart rate fluctuation acquired by the heart rate acquisition unit is caused by a drink intake, on a basis of the feature extracted by the feature extraction unit and the information stored in the storage. The action information detection device 106 acts as an example of an action information measuring device configured to measure action information of the object. The body function quantification unit 50 acts as an example of a quantification unit configured to quantify a body function of the object on a basis of a relationship between the feature extracted by the feature extraction unit and the information stored in the storage when the determination unit determines that the heart rate fluctuation acquired by the heart rate acquisition unit is caused by the drink intake.

[0070] Embodiments of the present invention have been described in detail. However, the present invention is not limited to the specific embodiments but may be varied or changed within the scope of the claimed invention.

Claims

1. An information processing device (100) comprising:

a heart rate acquisition unit (10) configured to acquire a heart rate of an object;
 a feature extraction unit (20) configured to extract a feature from heart rate fluctuation with respect to time that is acquired by the heart rate acquisition unit (10), the feature including an average and a variation before an increasing of the heart rate is detected and an average and a variation after the heart rate returns to a predetermined value after the increasing;
 a storage (40) configured to, in advance, store information associated with heart rate fluctuation of a drink intake; and
 a determination unit (30) configured to determine whether the heart rate fluctuation acquired by the heart rate acquisition unit (10) is caused by a drink intake, on a basis of the feature extracted by the feature extraction unit and the information stored in the storage.

2. The information processing device (100) as claimed in claim 1, **characterized in that**

the determination unit (30) is configured to determine that the heart rate fluctuation acquired by the heart rate acquisition unit (10) is caused by the drink intake, when a coincidence between the feature extracted by the feature extraction unit and a feature extracted from the information stored in the storage is equal to a threshold or more.

3. The information processing device (100) as claimed in claim 1, **characterized in that:**

the storage (40) is configured to, in advance, store information associated with heart rate fluctuation with respect to time of a drink non-intake; and
 the determination unit (30) is configured to determine that the heart rate fluctuation acquired by the heart rate acquisition unit (10) is caused by the drink intake, when a coincidence between the feature extracted by the feature extraction unit and a feature extracted from the information stored in the storage is larger than a coincidence between the feature extracted by the feature extraction unit and a heart rate feature of the drink non-intake extracted from the information stored in the storage.

4. The information processing device (100) as claimed in any of claims 1 to 3, **characterized in that**

the coincidence is calculated on a basis of one of an Euclid distance, a normalized Euclid distance and a Mahalanobis distance.

5. The information processing device (100) as claimed in any of claims 1 to 4, **characterized by** further comprising:

an action information measuring device (106) configured to measure action information of the object, wherein the determination unit (30) is configured to use the action information measured by the action information measuring device when determining whether the heart rate fluctuation acquired by the heart rate acquisition unit (10) is caused by the drink intake.

- 5 6. The information processing device (100) as claimed in any of claims 1 to 5, **characterized by** further comprising: a quantification unit (50) configured to quantify a body function of the object on a basis of a relationship between the feature extracted by the feature extraction unit (20) and the information stored in the storage (40) when the determination unit (30) determines that the heart rate fluctuation acquired by the heart rate acquisition unit (10) is caused by the drink intake.
- 10 7. The information processing device (100) as claimed in any of claims 1 to 6, **characterized by** further comprising: a drink intake amount estimation unit (30) configured to estimate a drink intake amount with use of the feature extracted by the feature extraction unit and a period for one swallowing of a drink that is stored in the storage in advance, when the determination unit determines that the heart rate fluctuation acquired by the heart rate acquisition unit (10) is caused by the drink intake.
- 15 8. The information processing device (100) as claimed in any of claims 1 to 6, **characterized in that** the feature includes at least one of an increasing speed of heart rates and a decreasing speed of heart rates.
- 20 9. The information processing device (100) as claimed in any of claims 1 to 6, **characterized in that** the feature includes an error between heart rate fluctuation with respect to time and an approximated line of the heart rate fluctuation.
- 25 10. The information processing device (100) as claimed in any of claims 1 to 6, **characterized in that** the feature includes an intersection angle between an approximated line of heart rate fluctuation before a predetermined time and another approximated line of the heart rate fluctuation after a time of a maximum heart rate.
- 30 11. The information processing device (100) as claimed in claim 10, **characterized in that** the predetermined time is the time of the maximum heart rate.
- 35 12. The information processing device (100) as claimed in any of claims 1 to 6, **characterized in that** the feature includes a value based on a peak value of the heart rate.
13. The information processing device (100) as claimed in any of claims 1 to 6, wherein the feature includes an integral value from an increasing of the heart rate to returning to a predetermined value after the increasing.
- 40 14. The information processing device (100) as claimed any of claims 1 to 6, **characterized in that** the feature includes a wave pattern of the heart rate fluctuation.
- 45 15. The information processing device (100) as claimed in any of claims 1 to 6, **characterized in that** the feature includes one or more of an increasing speed of the heart rate, a decreasing speed of the heart rate, an error between heart rate fluctuation and an approximated line of the heart rate fluctuation, an intersection angle between an approximated line of the heart rate fluctuation before a time of the maximum heart rate and another approximated line of the heart rate fluctuation after the time of the maximum heart rate, a value based on a peak value of the heart rate, an integral value from the increasing of the heart rate to returning to a predetermined value after the increasing, and a wave pattern of the heart rate fluctuation.
- 50 16. The information processing device (100) as claimed in any of claims 1 to 6, **characterized in that** the feature includes an increasing speed of the heart rate, a decreasing speed of the heart rate, an error between the heart rate fluctuation and an approximated line of the heart rate fluctuation, and an intersection angle between an approximated line of the heart rate fluctuation before a time of a maximum heart rate and another approximated line of the heart rate fluctuation after the time of the maximum heart rate.
- 55 17. An information processing method executed by a computer, the information processing method comprising:
 acquiring a heart rate of an object;
 extracting a feature from heart rate fluctuation with respect to time that is acquired in the acquiring, the feature

including an average and a variation before an increasing of the heart rate is detected and an average and a variation after the heart rate returns to a predetermined value after the increasing; and determining whether the heart rate fluctuation acquired in the acquiring is caused by a drink intake, on a basis of the feature extracted in the extracting and information stored, in advance, in a storage storing the information associated with heart rate fluctuation of a drink intake.

18. An information processing program which causes the computer to carry out the information processing method according to claim 17.

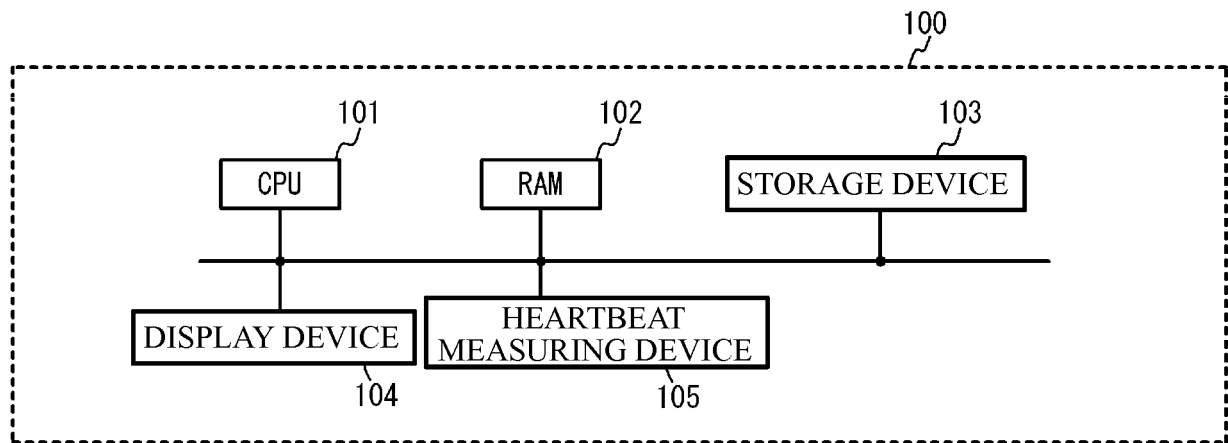

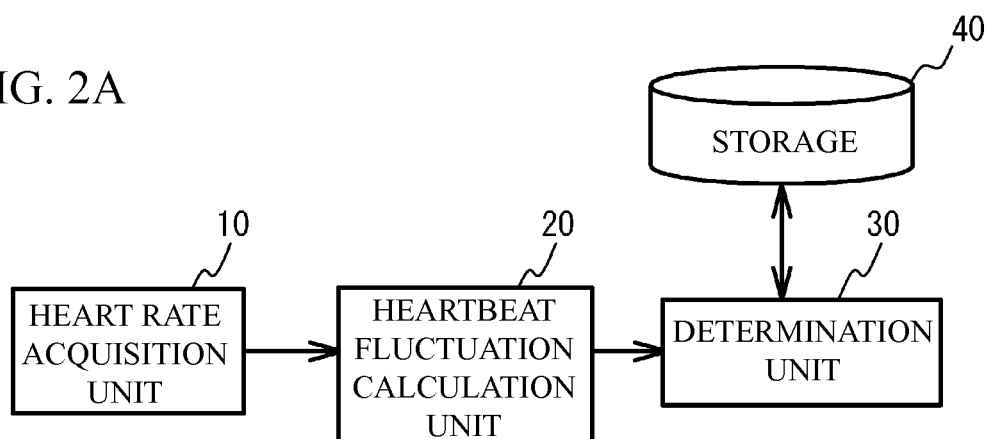

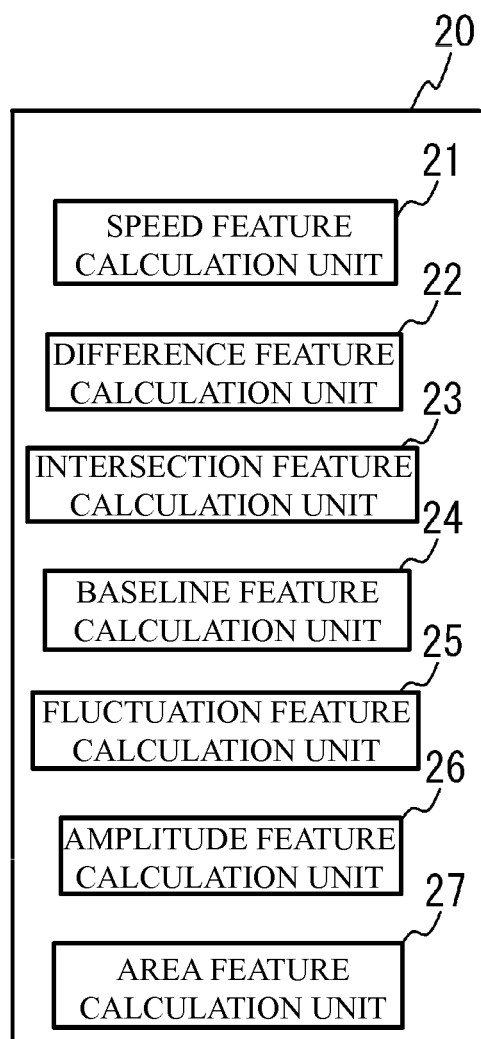

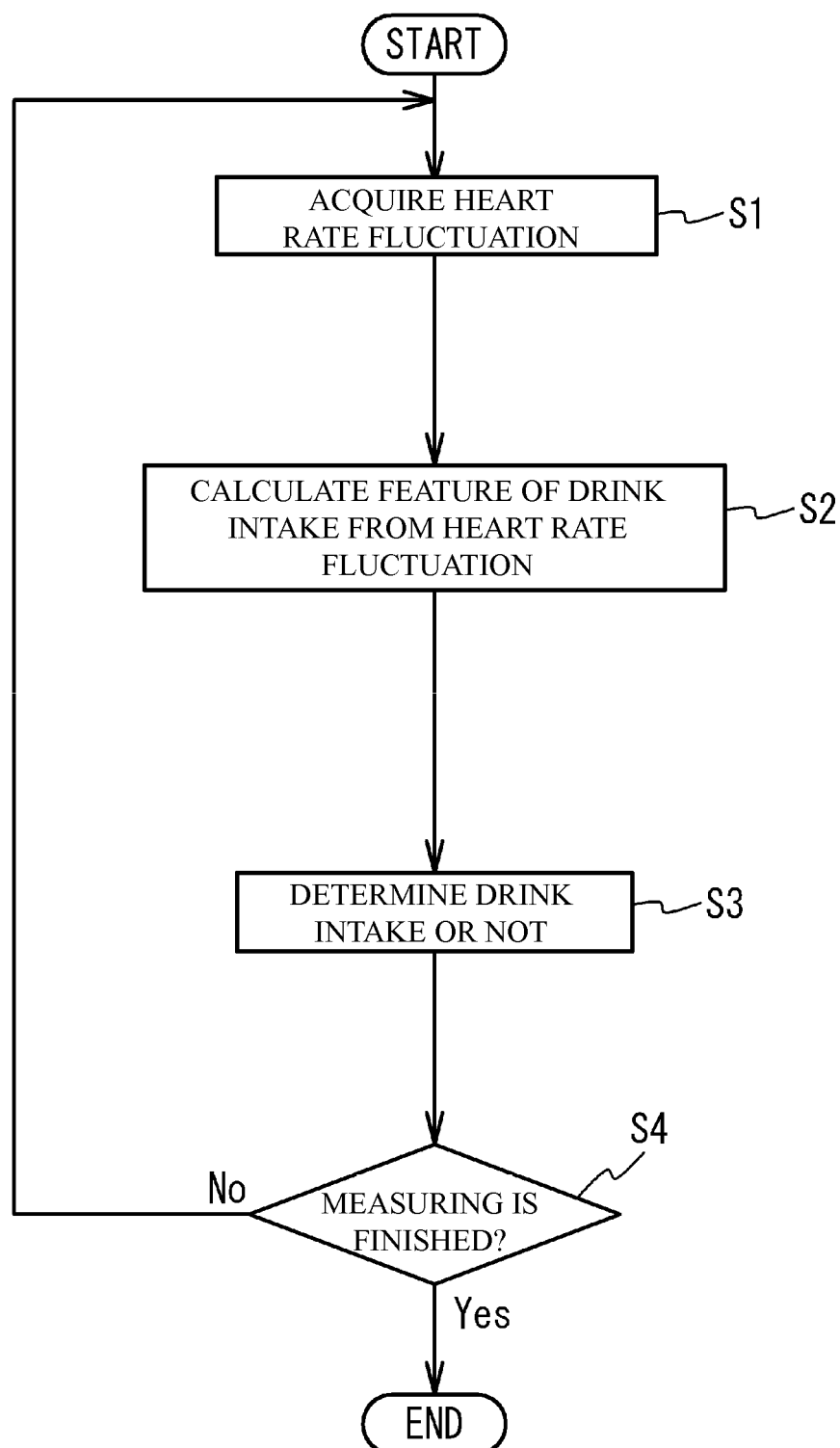

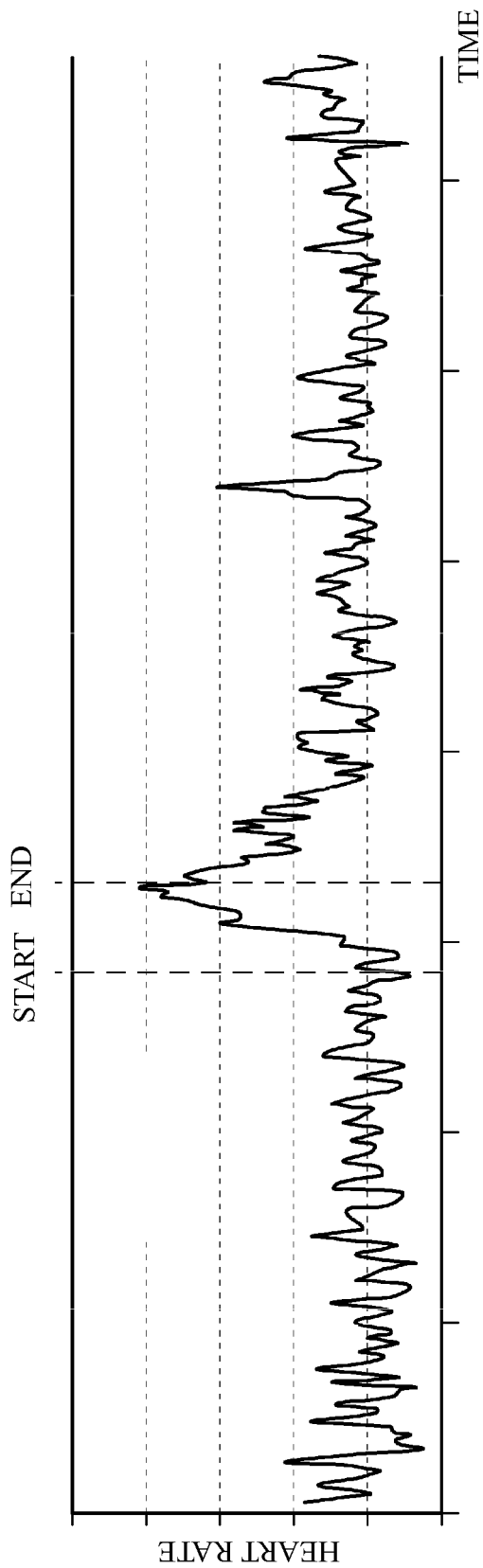

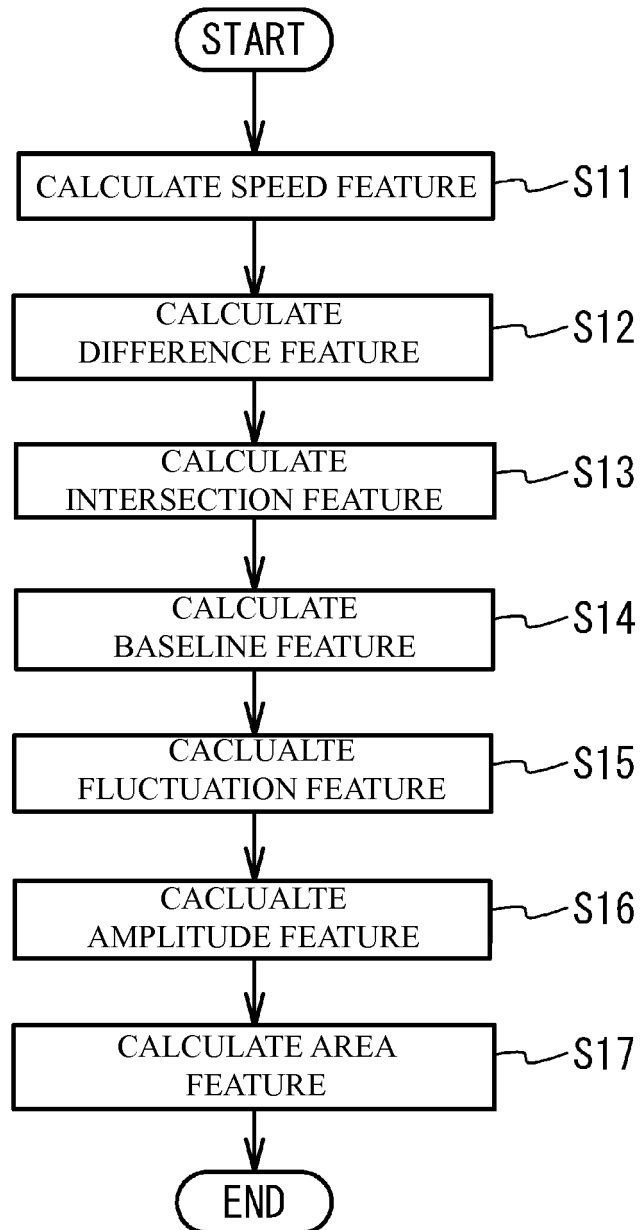

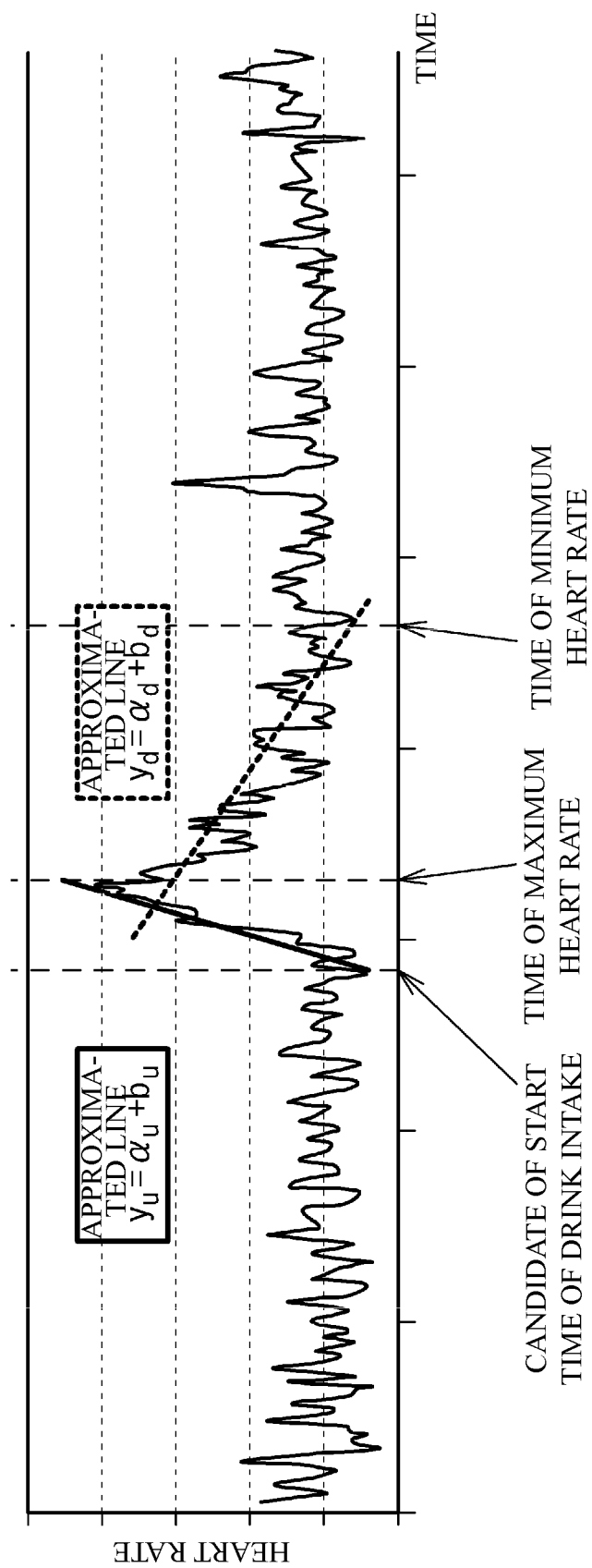

SPEED FEATURE>

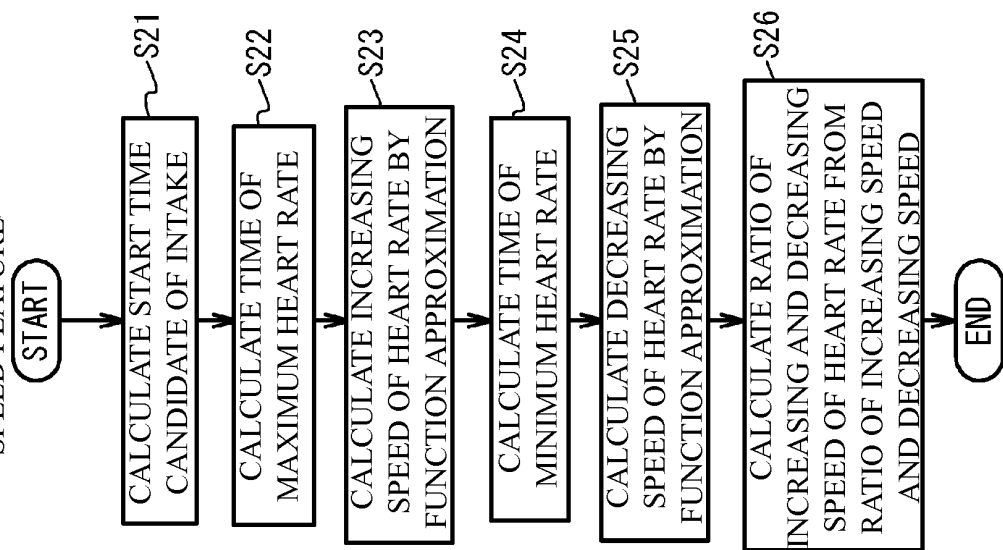

DIFFERENCE FEATURE>

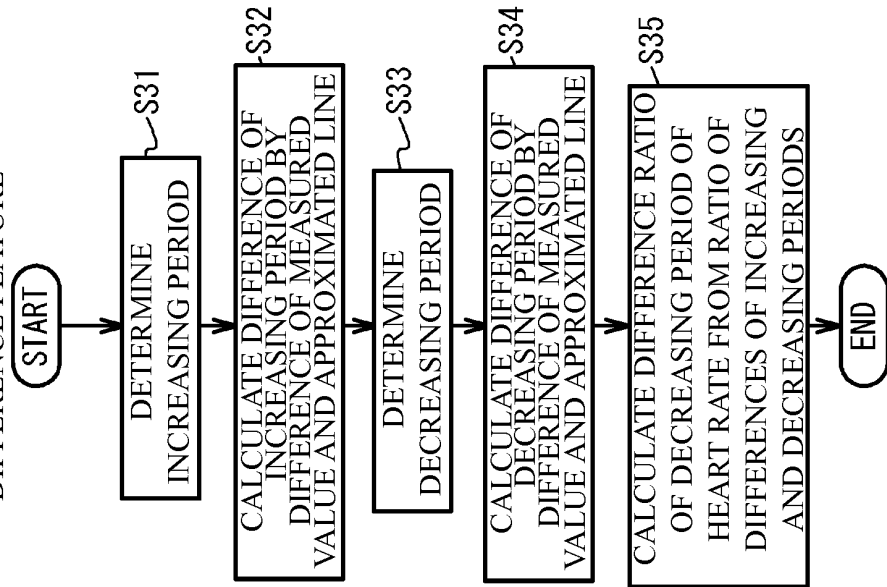

INTERSECTION FEATURE>

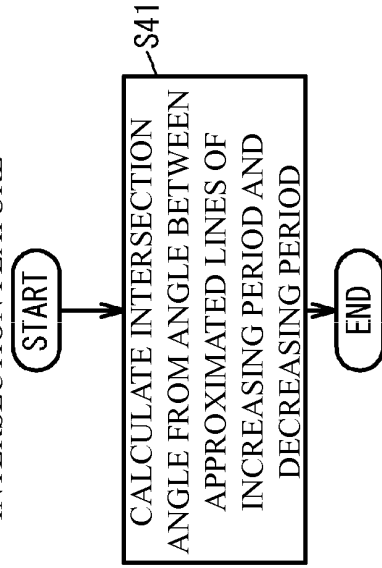

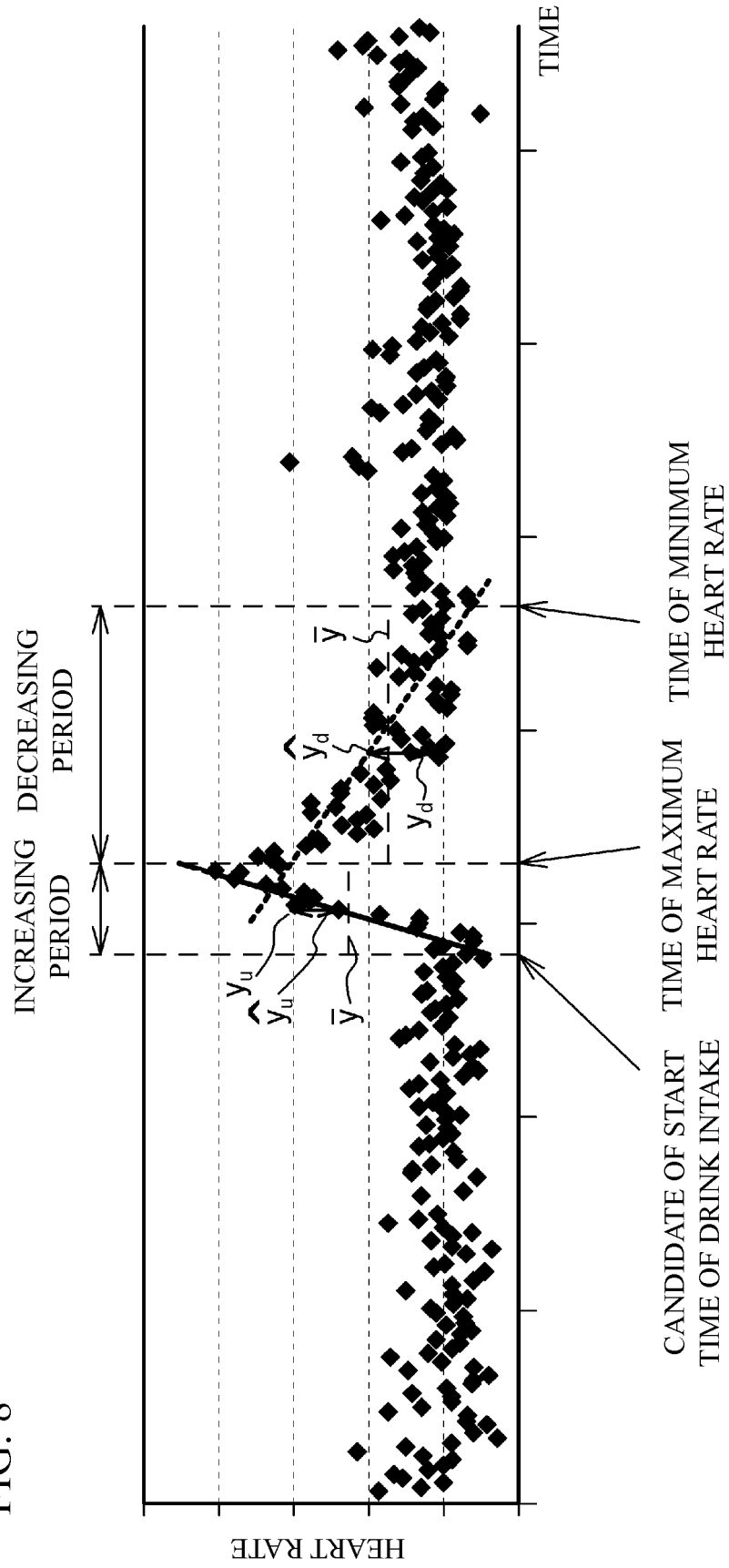

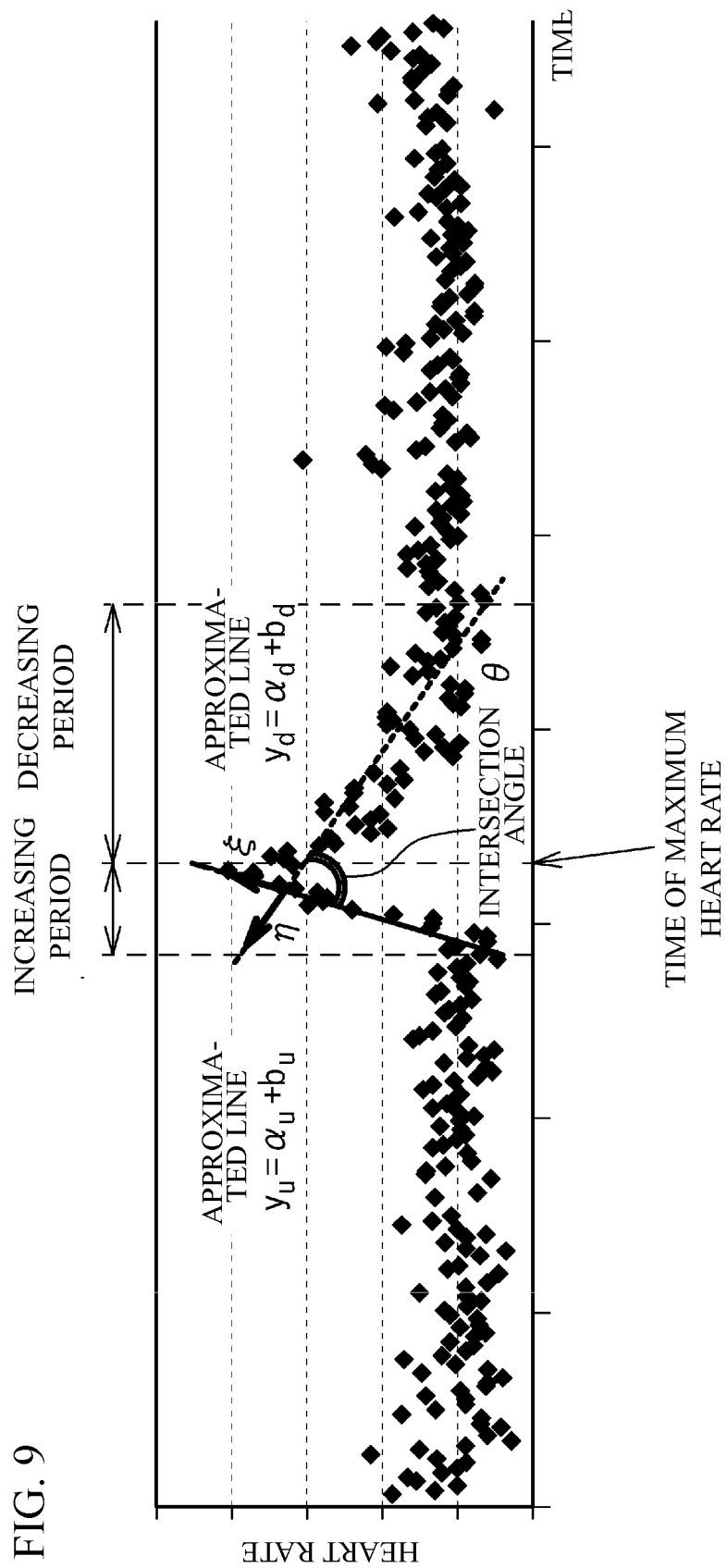

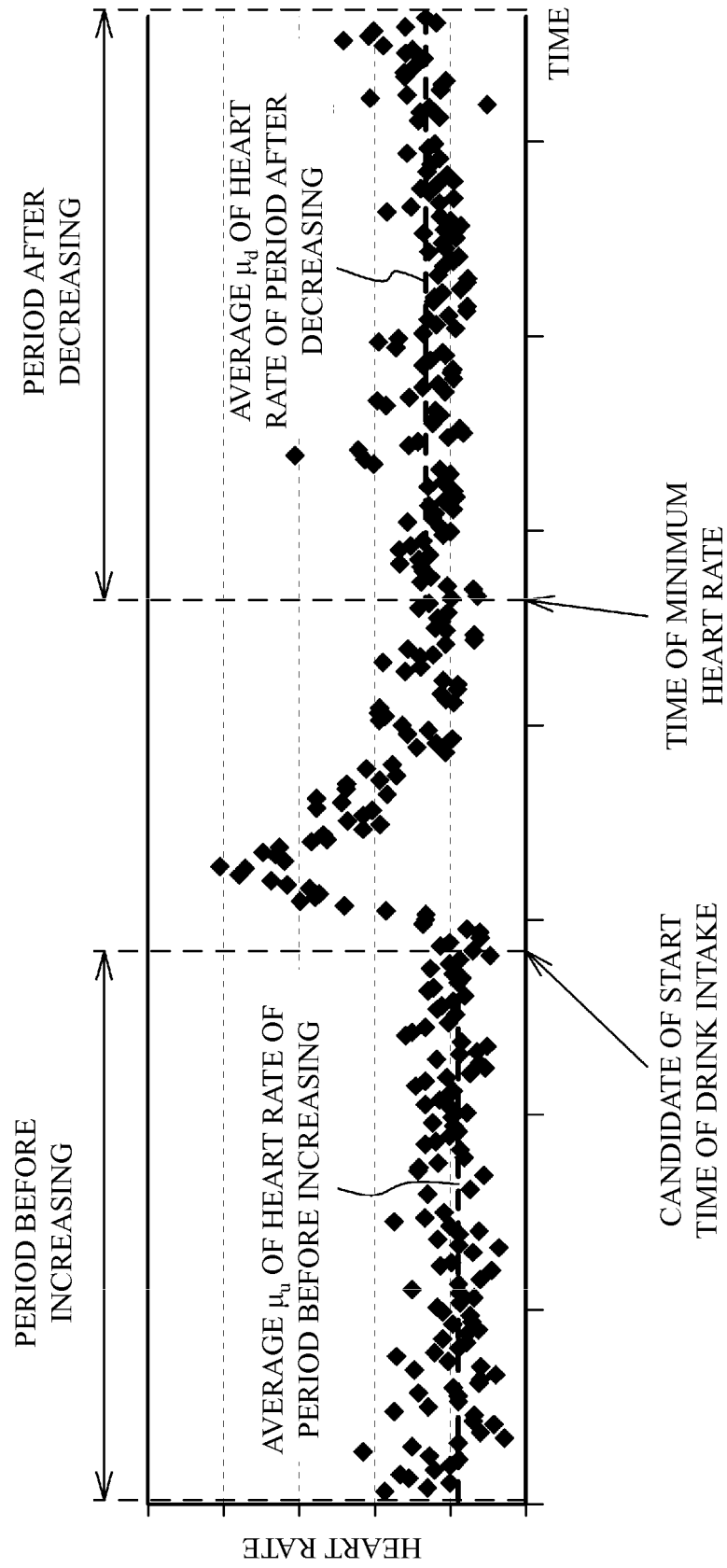

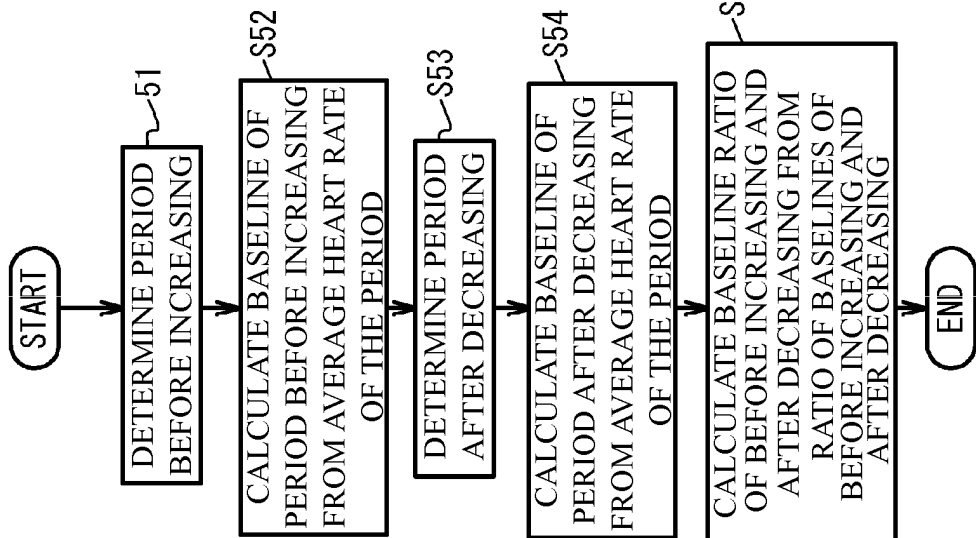
<CALCULATION OF

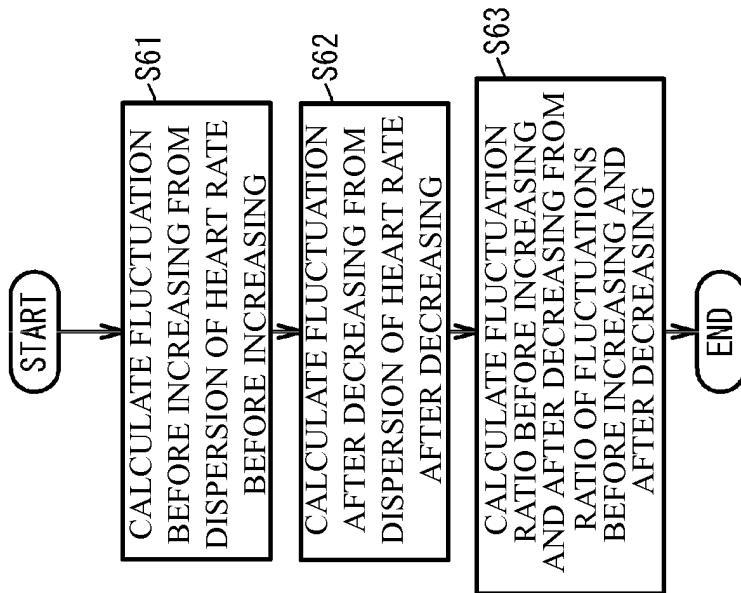
<CALCULATION OF

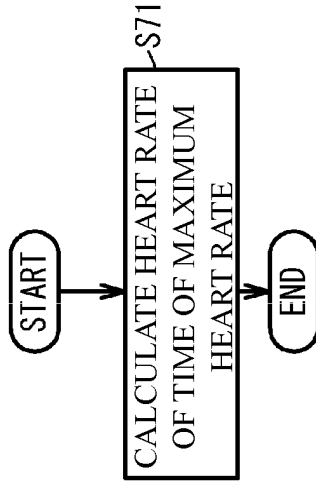
<CALCULATION OF

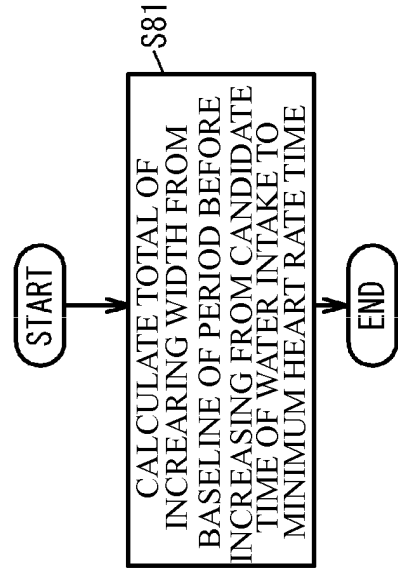
<CALCULATION OF

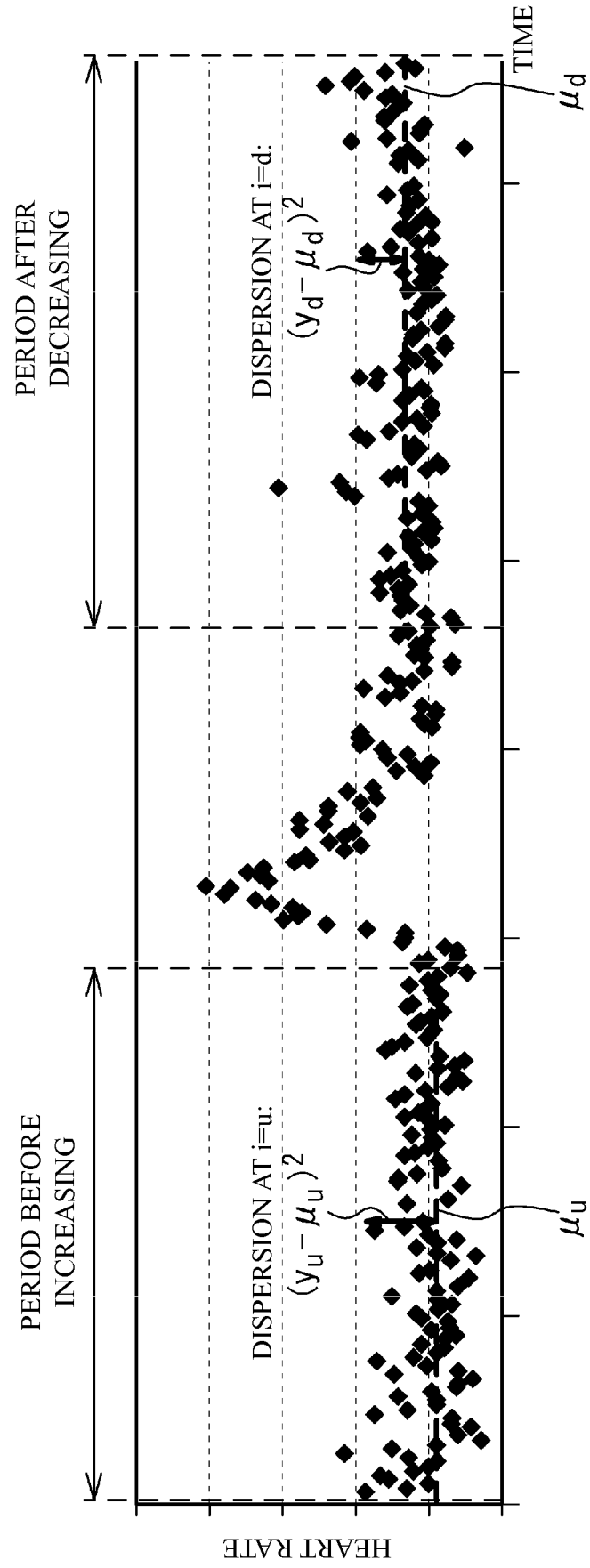

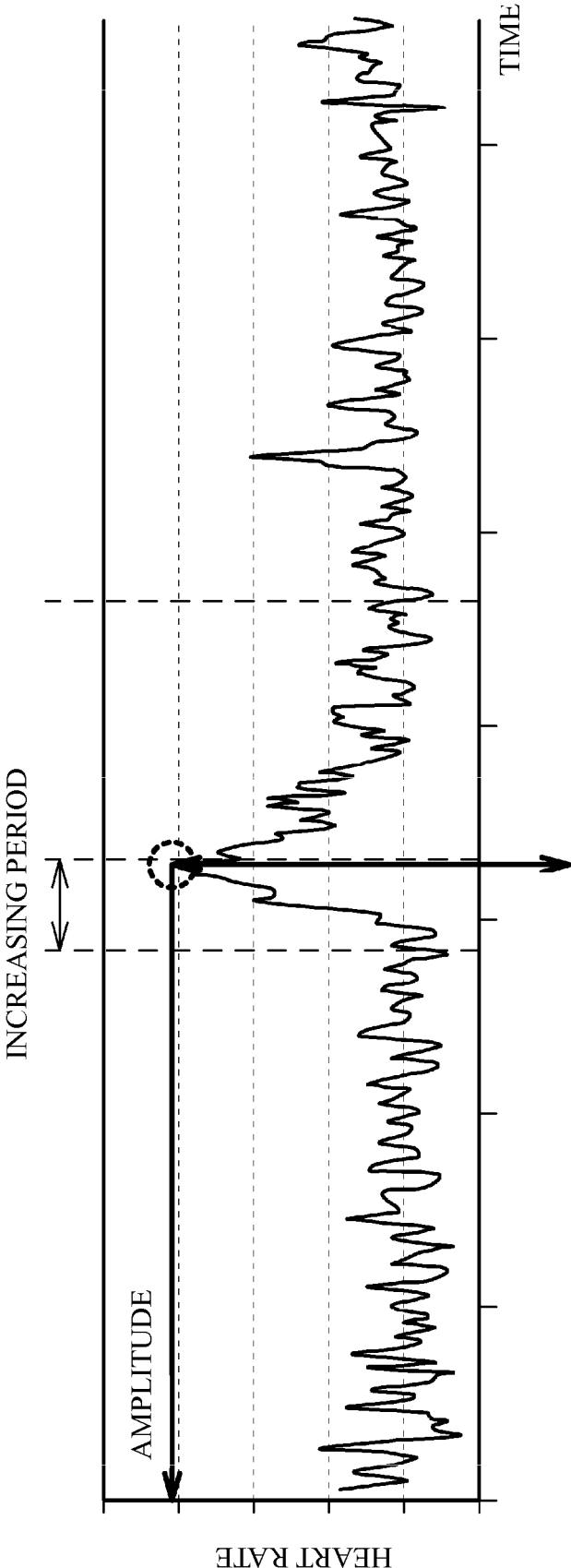
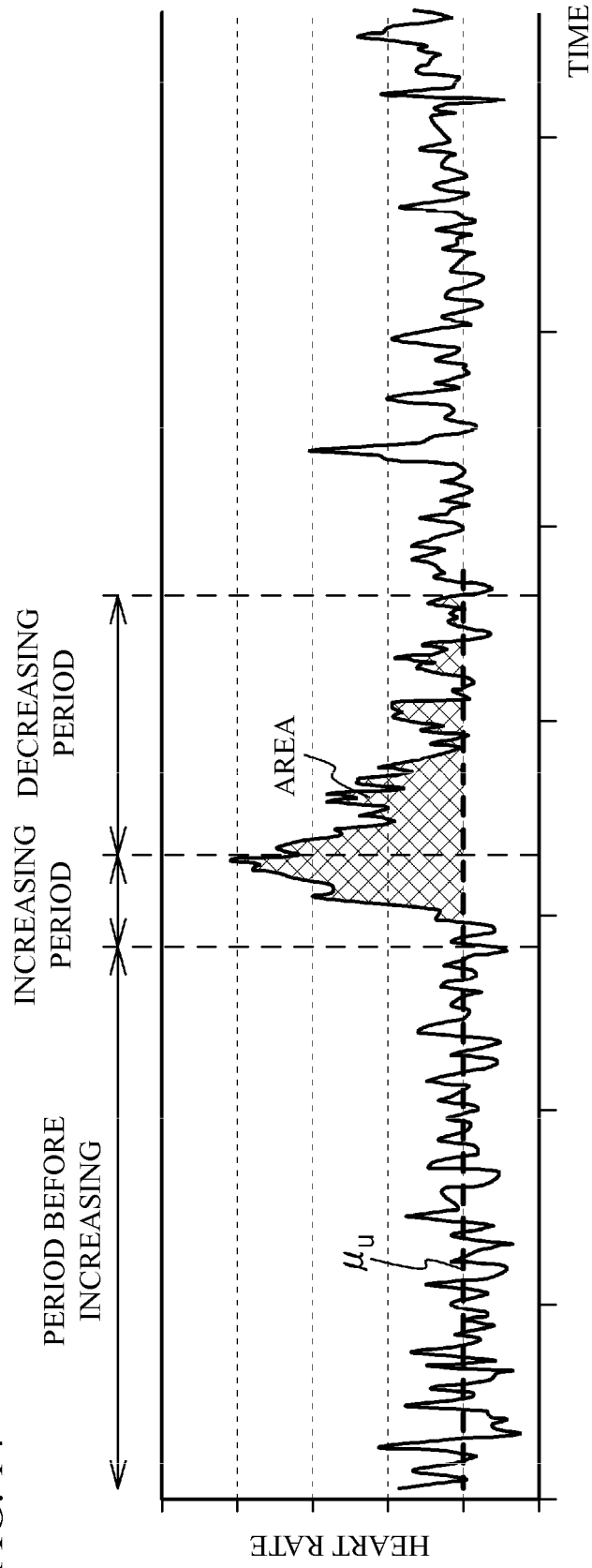

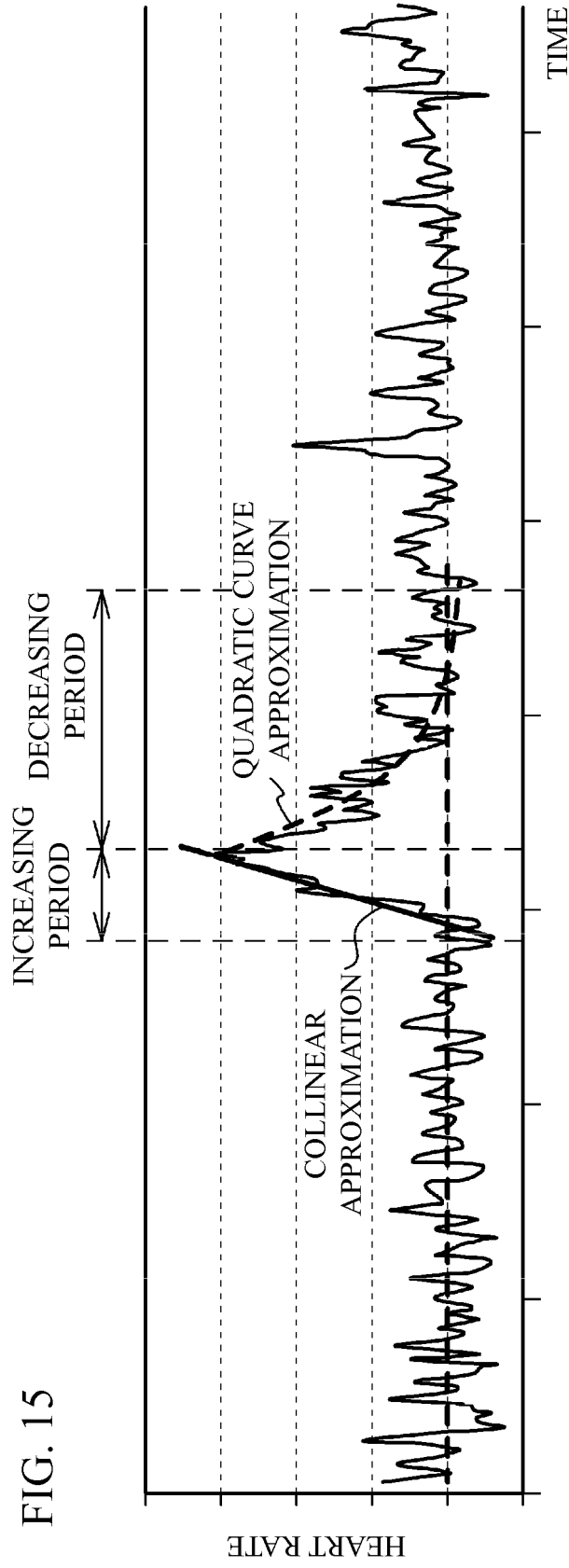

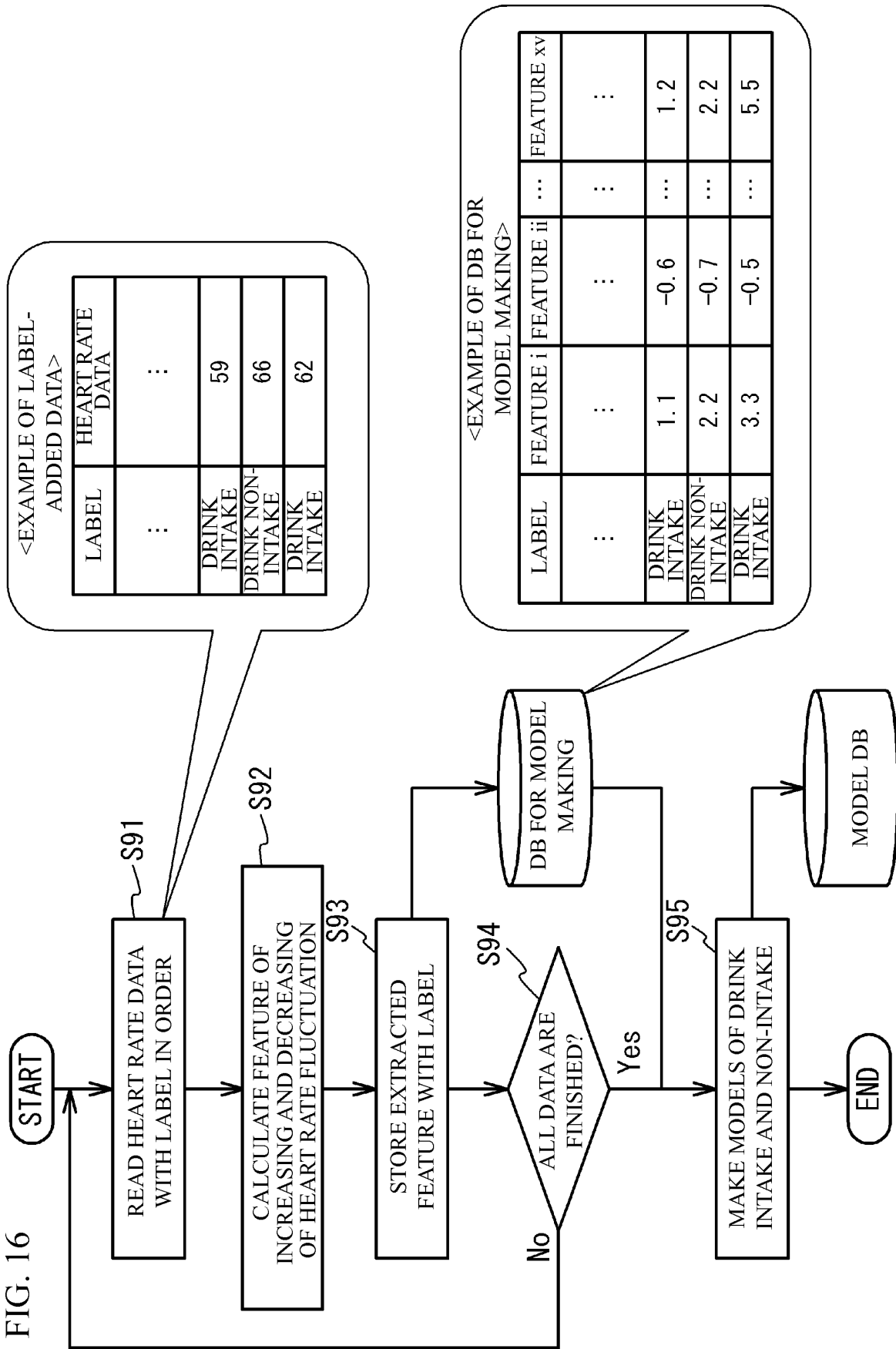

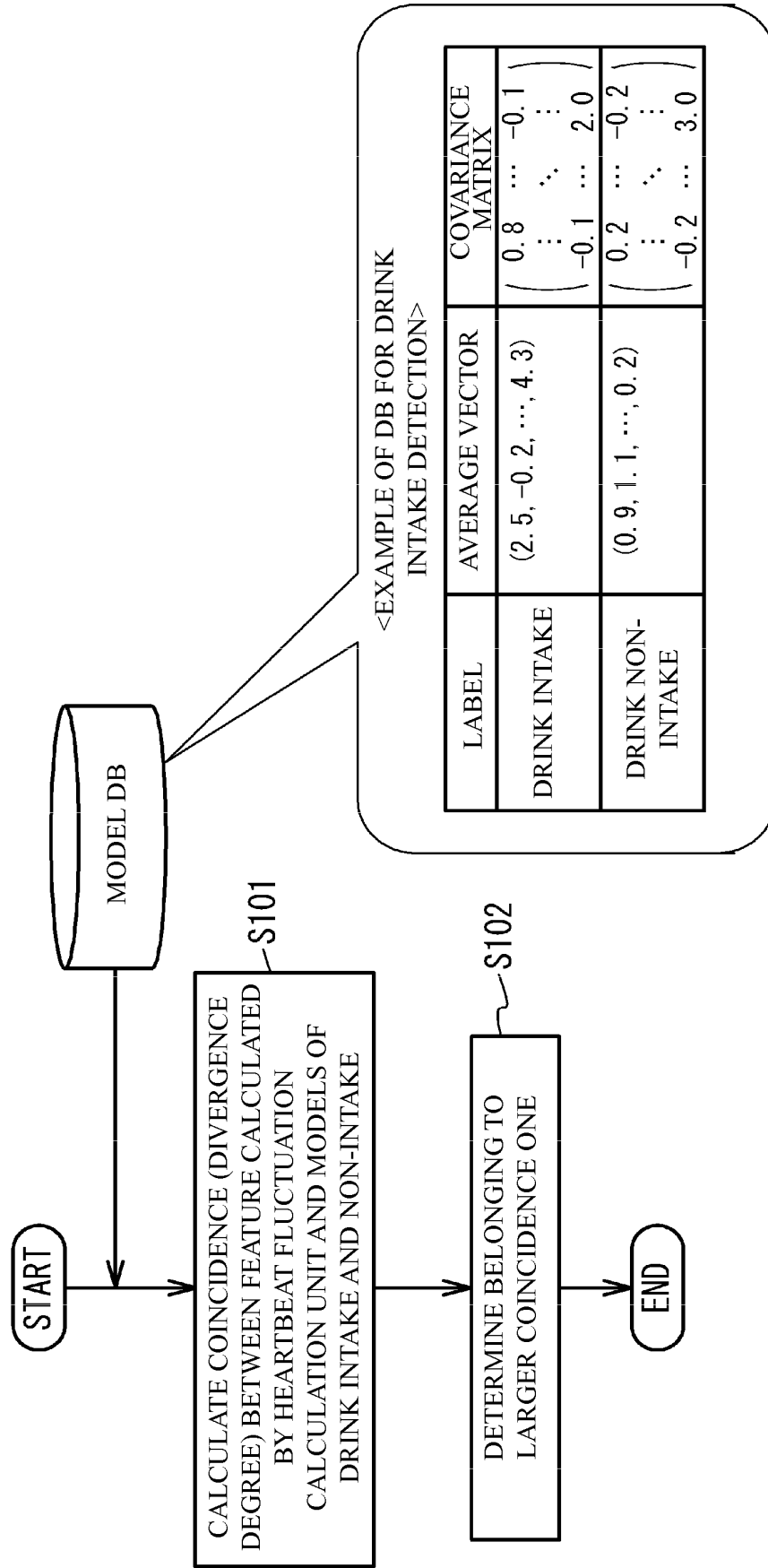

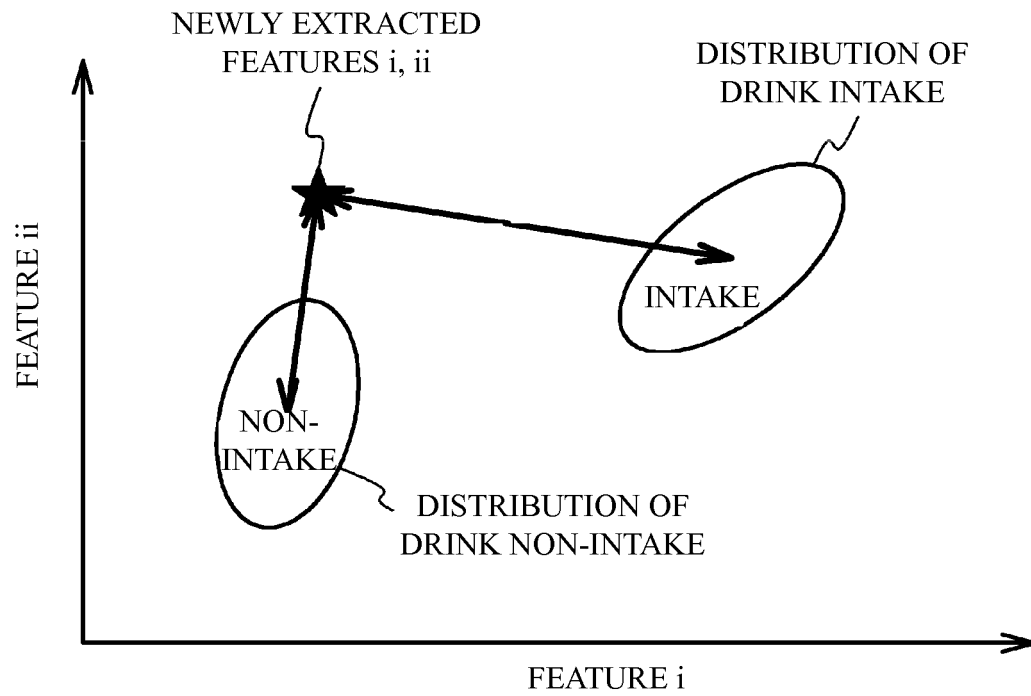

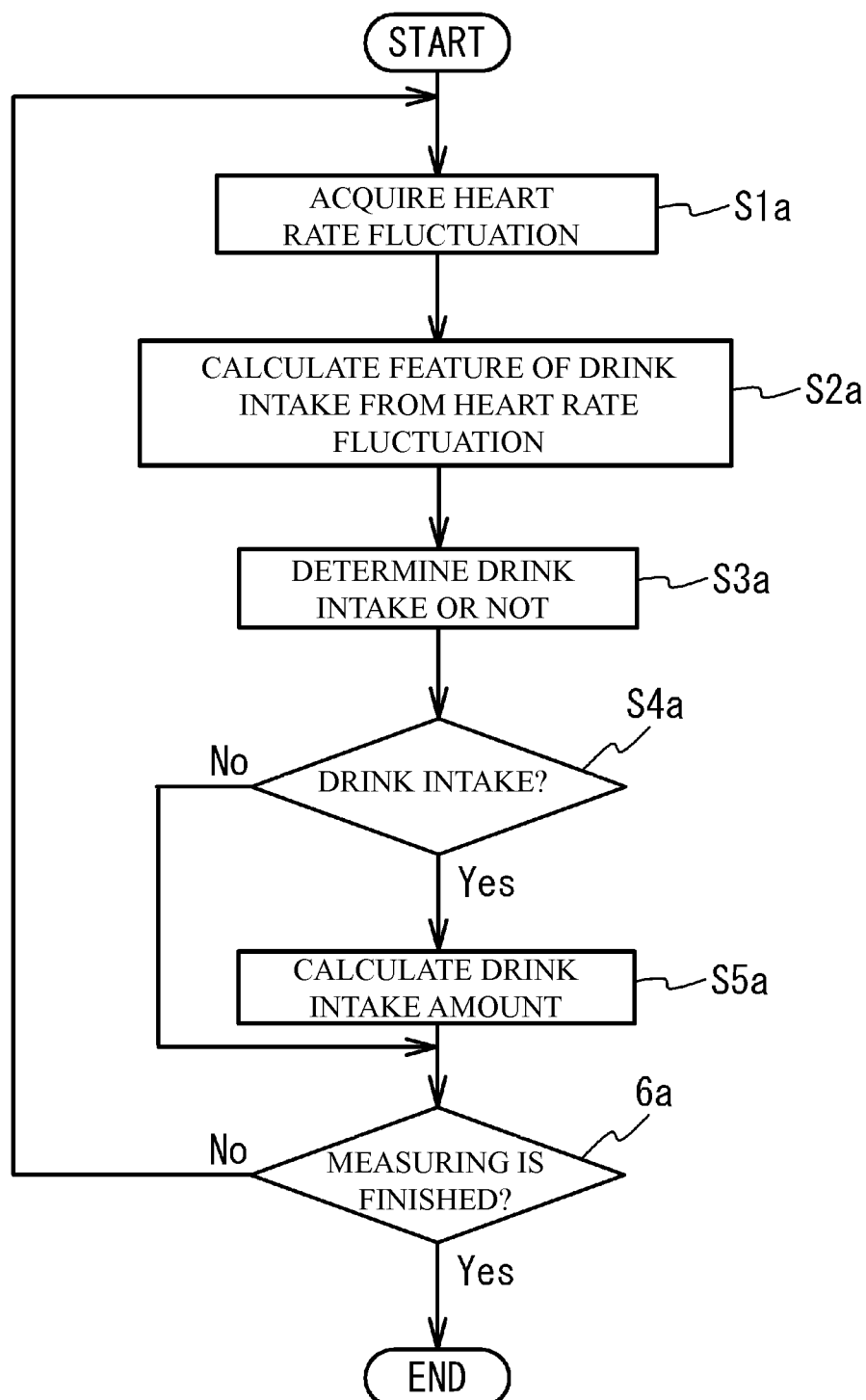

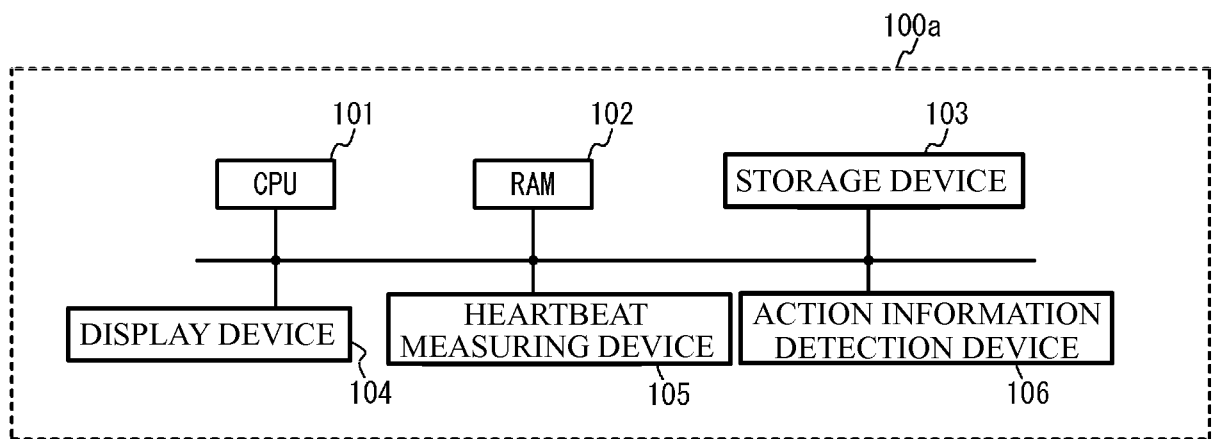

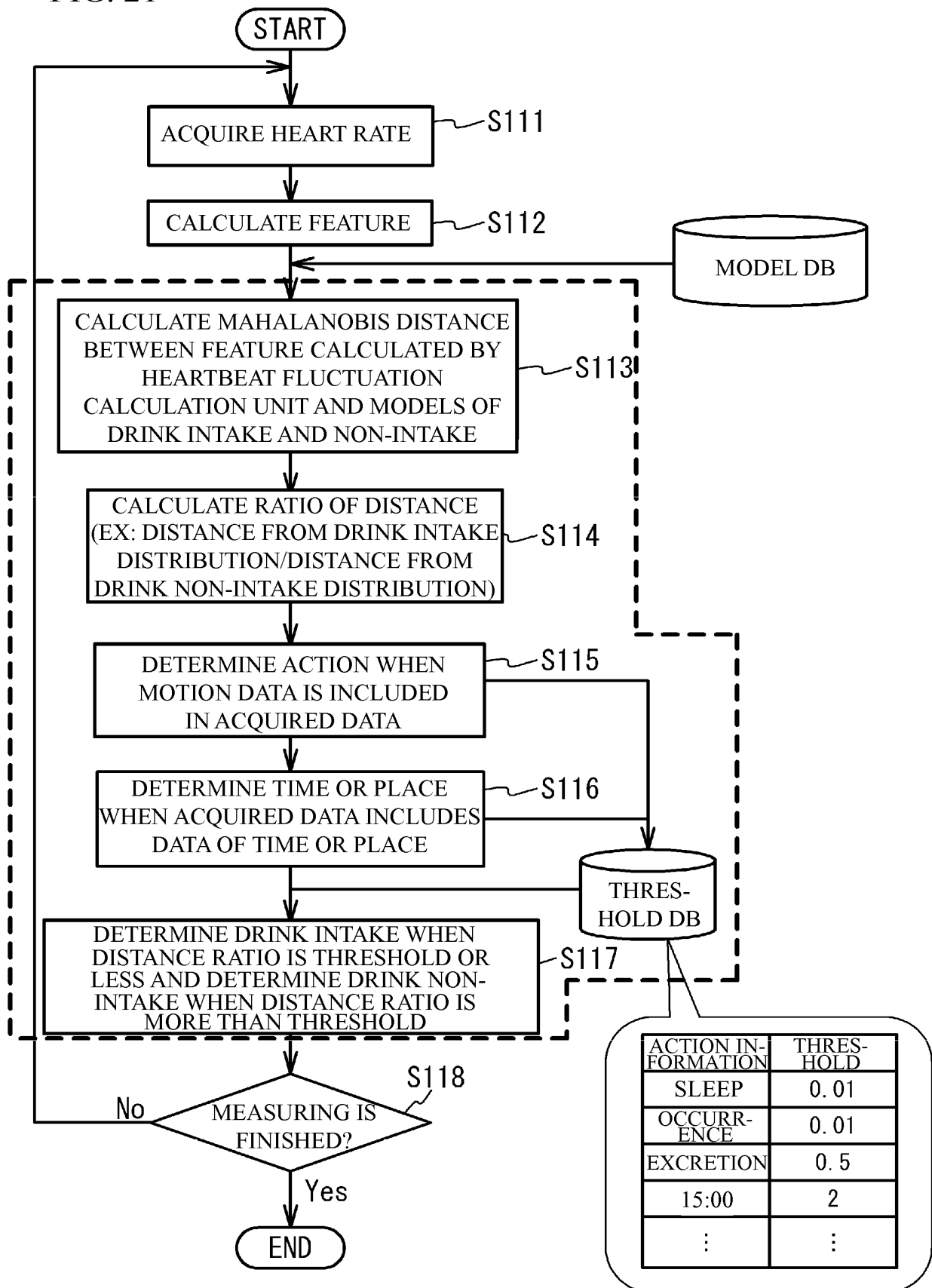

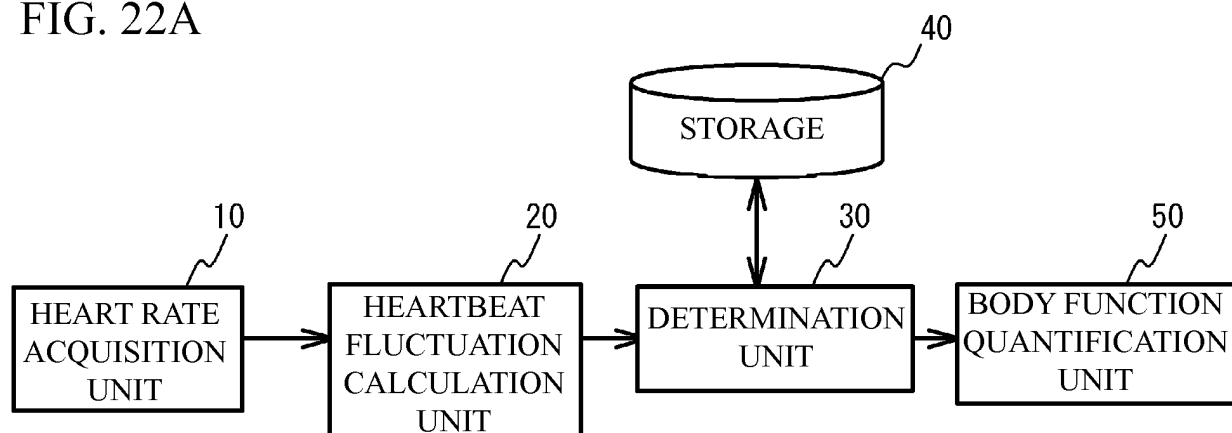

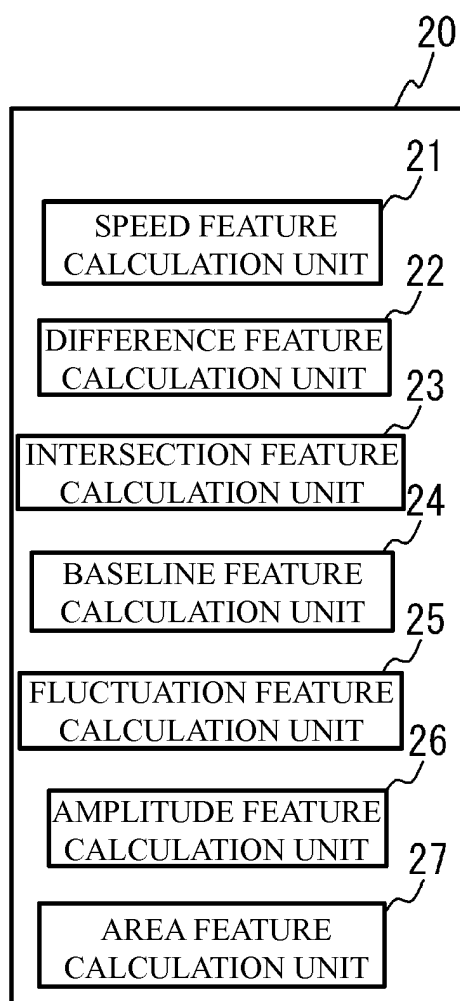

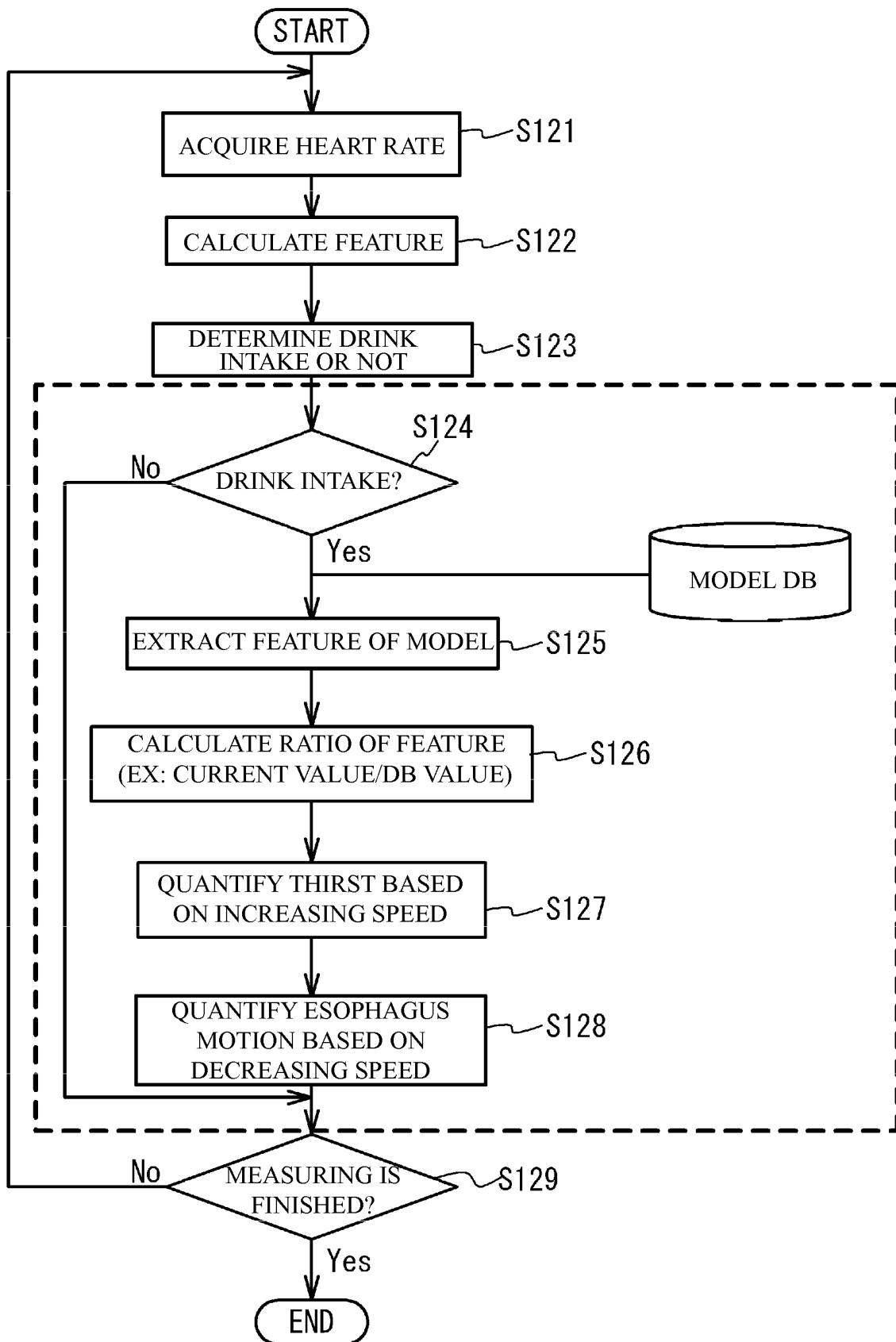

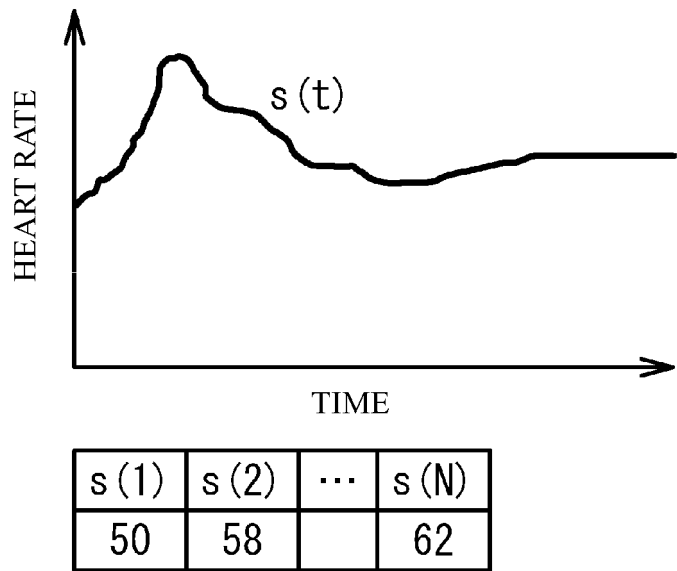

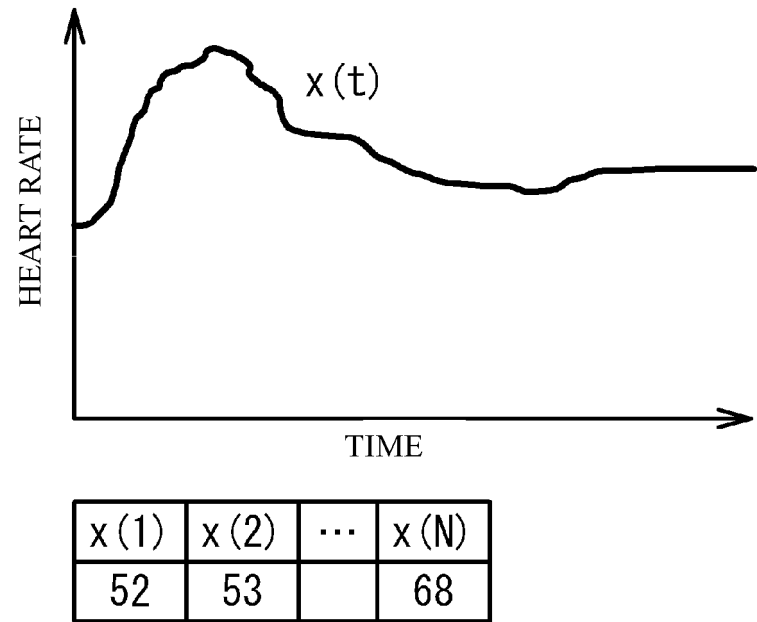

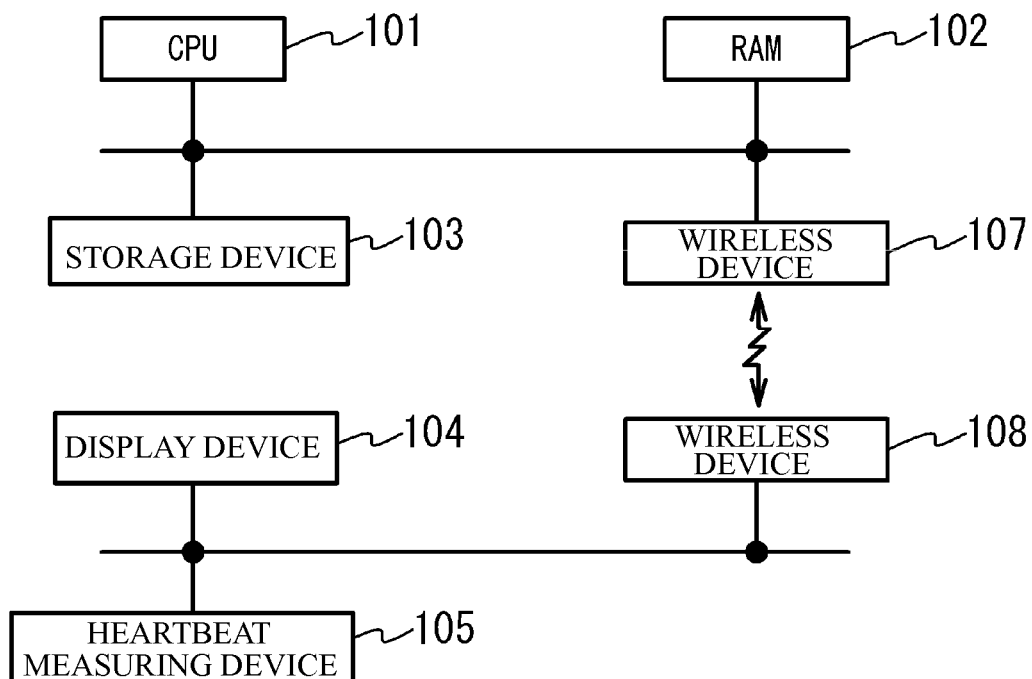
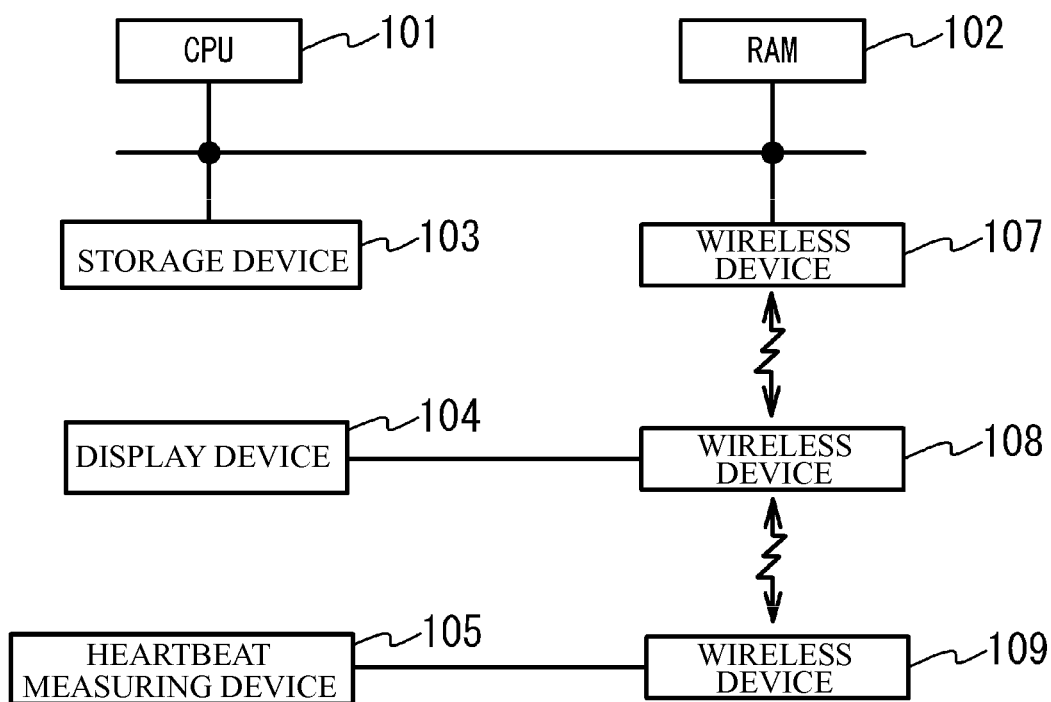

信息处理设备包括：心率获取单元，被配置为获取对象的心率；以及 特征提取单元，被配置为从心率获取单元获取的关于时间的心率波动中提取特征；存储器，其被配置为预先存储与饮料摄入的心率波动相关的信息；判断单元，其特征在于，根据所述特征提取单元提取的特征和所述存储器中存储的信息，判断所述心率获取单元获取的心率波动是否是由于饮酒引起的。
