(54) **Controlling of fitness exercise**

(57) A heart rate measuring arrangement comprising measuring means (410A-410B) for measuring the heart rate, forming means (452) for forming control information from the heart rate information obtained by measuring to control a recovery exercise, display means (450) for presenting the formed control information.

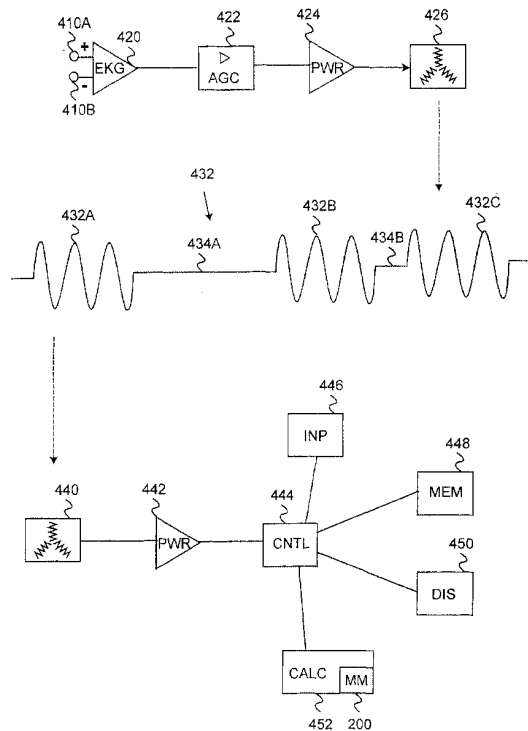

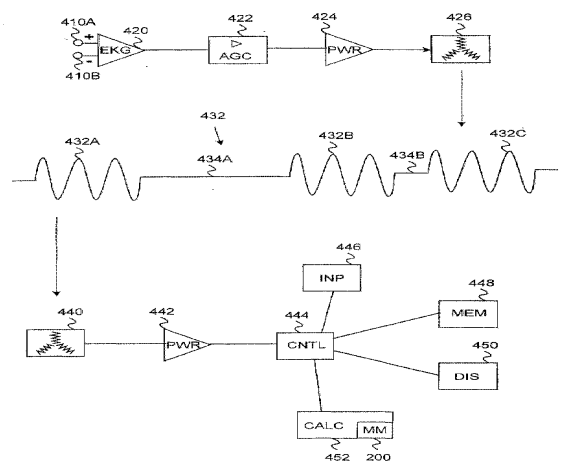
