#### 摘要(译)

用于监控用户身体特征的汽车监控系统包括至少一个传感器，用于监控至少一个用户身体特征。所述至少一个传感器可操作地连接到用户的身体，以在用户操作汽车时监控所述至少一个用户身体特征。至少一个用户身体特征至少是用户身体的葡萄糖水平。至少一个发射器可操作地耦合到至少一个传感器，以在用户操作汽车时传送从至少一个传感器获得的传感器数据。汽车电子装置可操作地连接到至少一个发射器，以在用户操作汽车时从至少一个传感器接收传感器数据。汽车电子设备在用户操作汽车时向用户提供传感器数据。全球定位系统 (GPS) 可操作地耦合到汽车电子设备以确定用户的当前位置。汽车电子设备基于从至少一个传感器接收的传感器数据限制用户操作汽车行进超过一定距离。
