摘要(译)

图像引导的超声系统可以包括超声探头,被配置为与超声探头通信以接收超声信号以显示来自超声探头的图像的显示器,以及可以附接到超声探头或与超声探头集成并且被配置的成像设备。与显示器通信以显示从成像装置的图像导出的信息。成像装置可包括稳定组件,物理地耦合到稳定组件的成像装置组件,物理地耦合到稳定组件的多个光敏装置,以及物理地耦合到成像装置组件的存储器单元,存储器单元被配置存储图像引导超声系统的校准或使用信息。
