#### 摘要(译)

检测生物样品中第一物种的Ig-CTF的方法，包括将生物样品暴露于优先结合第一物种的Ig-CTF或抗体的抗原结合片段，形成混合物的第二物种的第一抗体，将混合物暴露于第二种抗体或第三种物种的抗原结合片段，其优先结合第一物种的Ig-CTF，并检测生物样品中的Ig-CTF。
