The present claims 1- 8, 10-17 and 19-24 relate to an extremely large number of possible proteins. Support and disclosure within the meaning of Articles 84 and 83 EPC are to be found, however, for only a very small proportion of the uses, methods and kits claimed (see the descriptions pages 66 to 68), namely for the protein biomarkers of claims 9 and 18. Although all the different proteins listed in tables 4 and 5 were tested, from the individual comparisons and time course regulations only 16 candidate biomarkers were identified: the protein biomarkers of claims 9 and 18. Non-compliance with the substantive provisions is such that a meaningful search of the whole claimed subject-matter of the claims could not be carried out (Rule 63 EPC and Guidelines B-VIII, 3). The extent of the search was consequently limited.

The search of claims 1-24 was restricted to those claimed uses, methods and kits which appear to be supported, the protein markers listed in dependent claims 9 and 18 ( the same protein biomarker candidates identified and listed in the description pages 66-68).
